Now the deed witnesses:

1. That in consideration of the sanction of the plans by M.N.A.C., Authority for construction of the basement the executant undertakes that he/she shall at all times keep M.N.A.C., Authority free from any liability, loss or damages/ flowing from any injury or damage caused to the adjoining built up properties or to any person as a consequence of the construction of at the time of digging of its foundations or during the course of its construction or at any time thereafter.
