

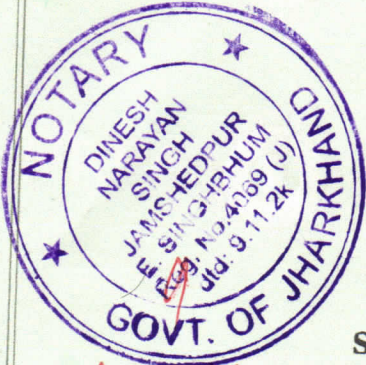

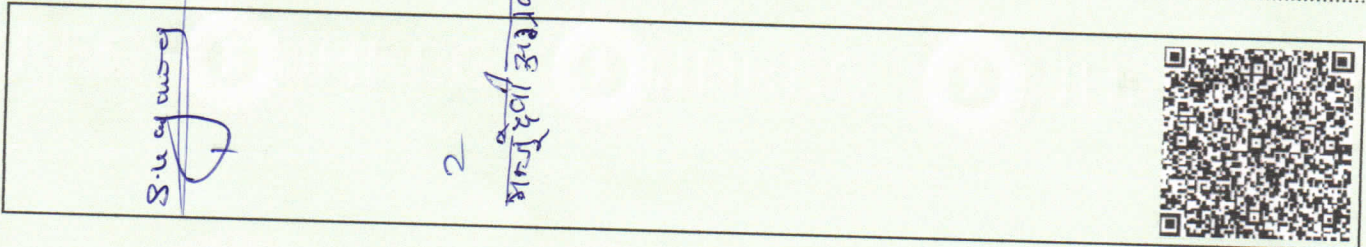

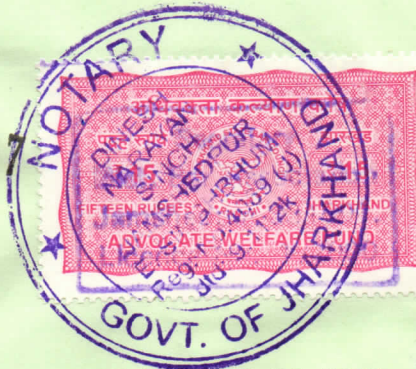

.....under the provisions of the building Bye laws made there under whereas the concerned authority has agreed to sanction the aforesaid construction subject to the conditions that the owner

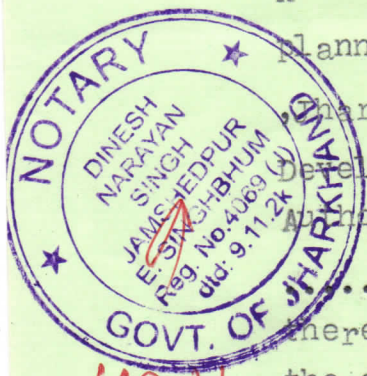

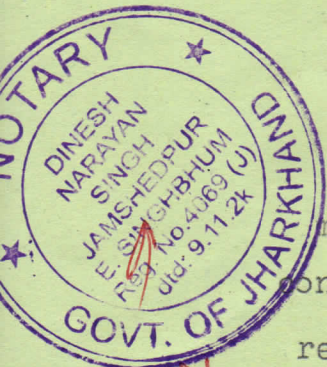

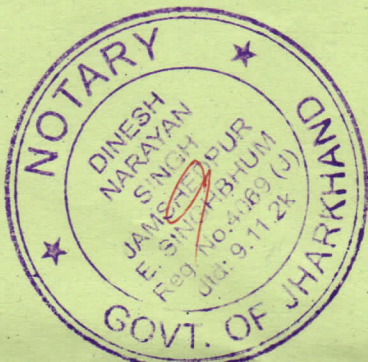
