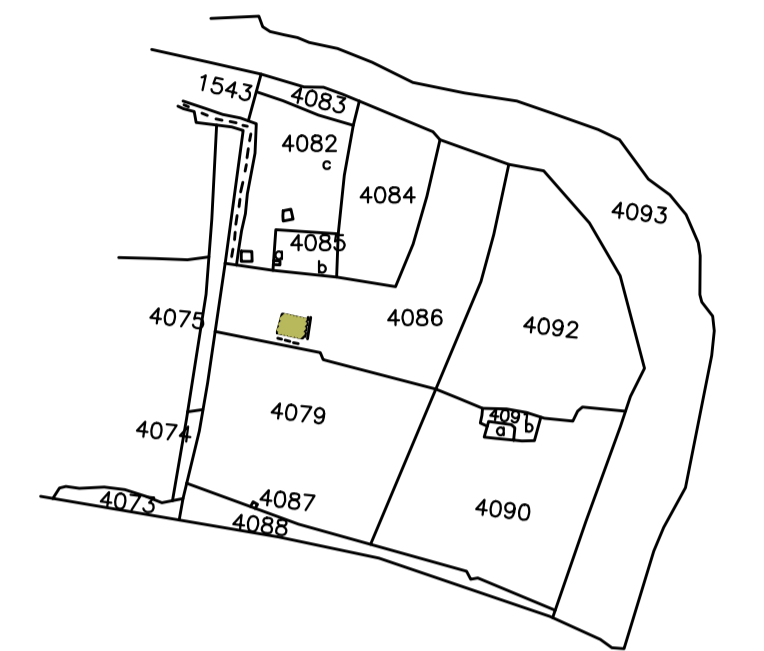

TERRACE FLOOR PLAN (SCALE 1:100)

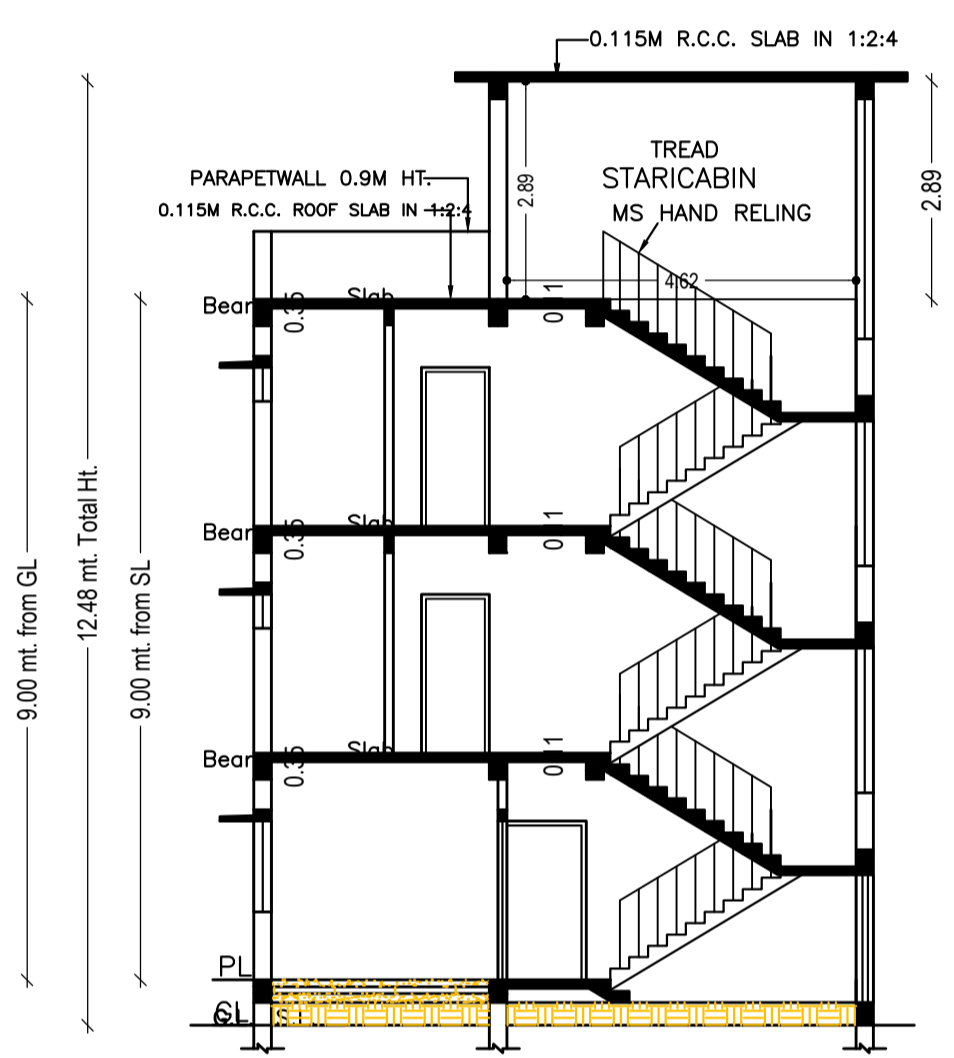
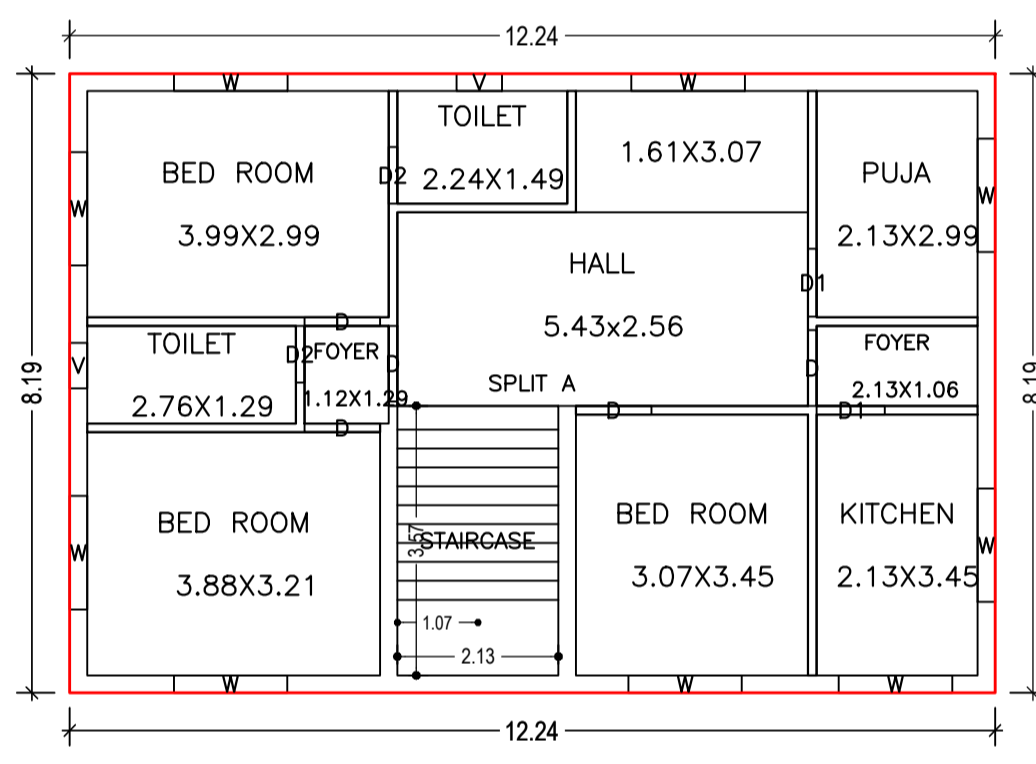

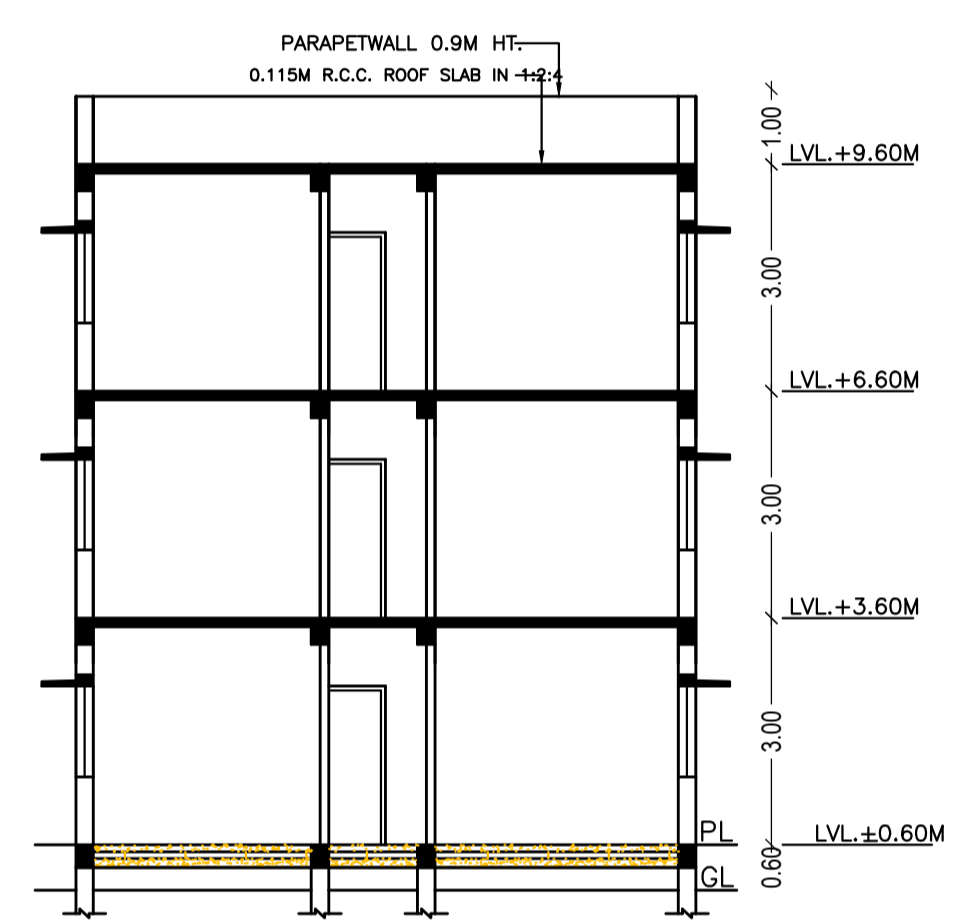

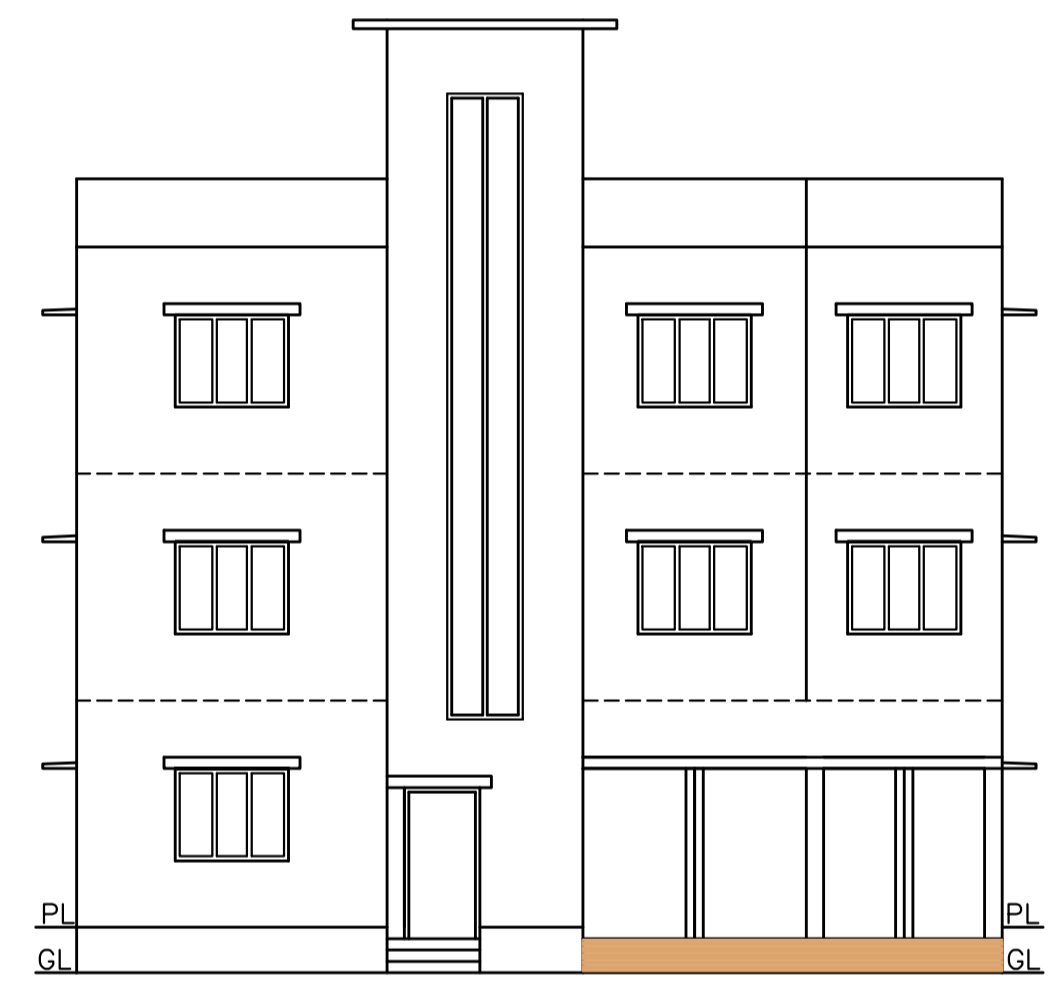
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)



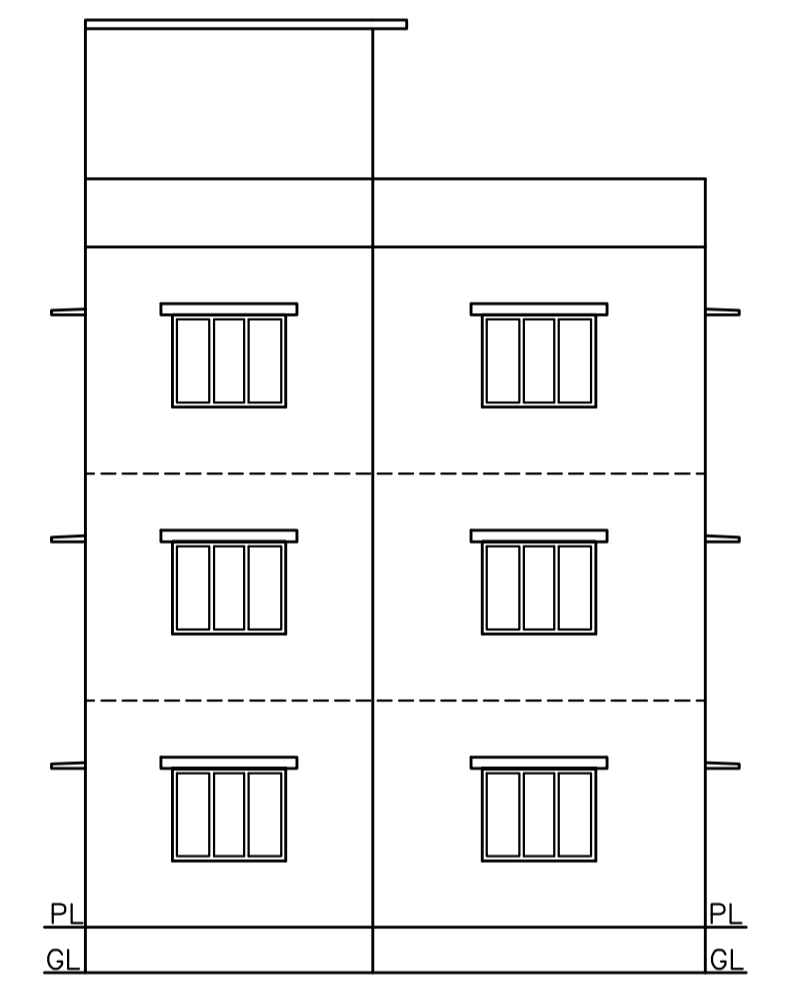
SECTION- AA SCALE 1:100

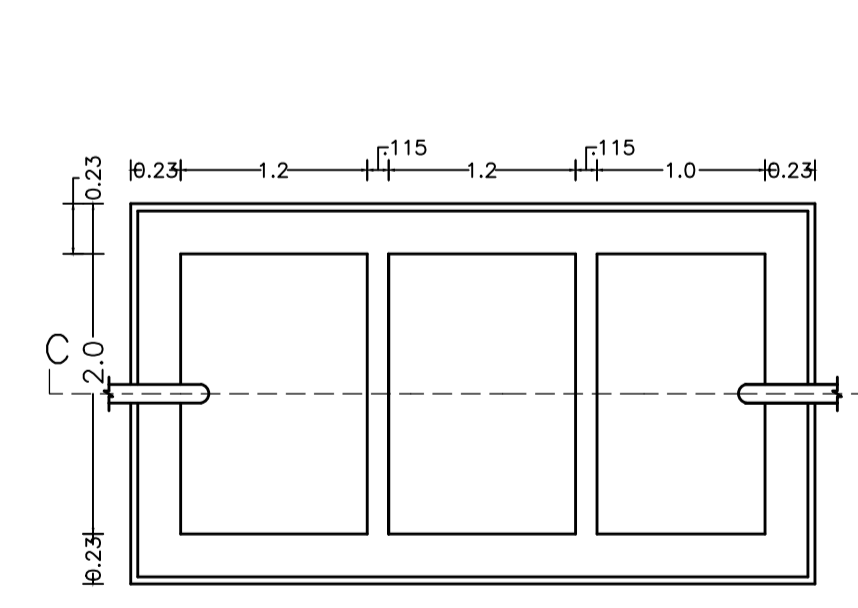


FRONT ELEVATION SCALE 1:100

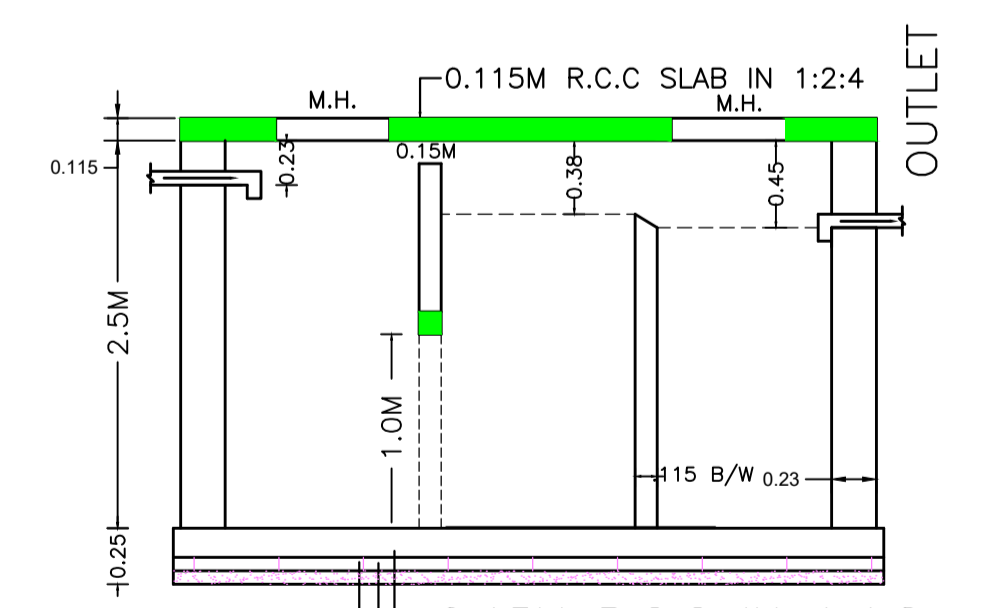


EAST SIDE ELEVATION SCALE 1:100

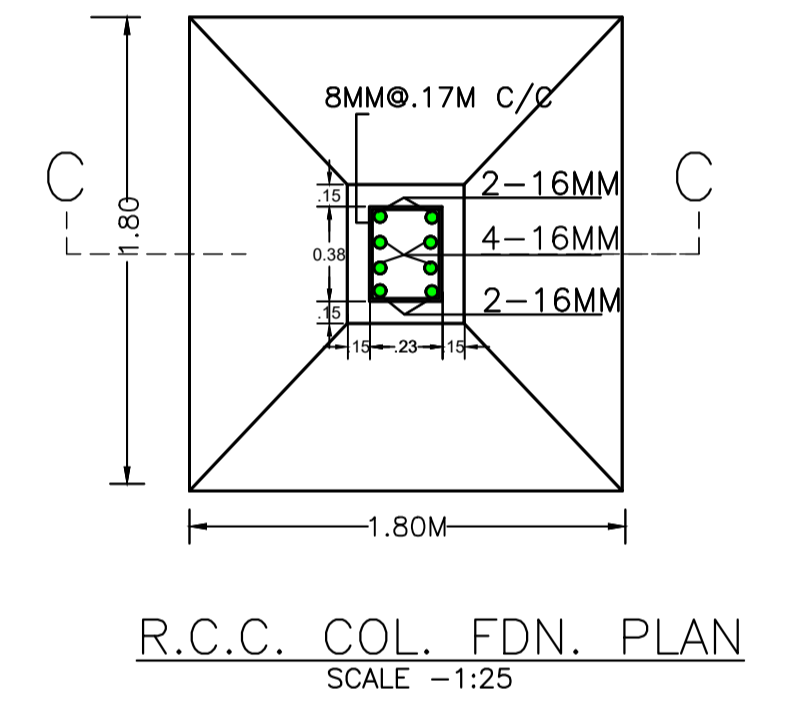
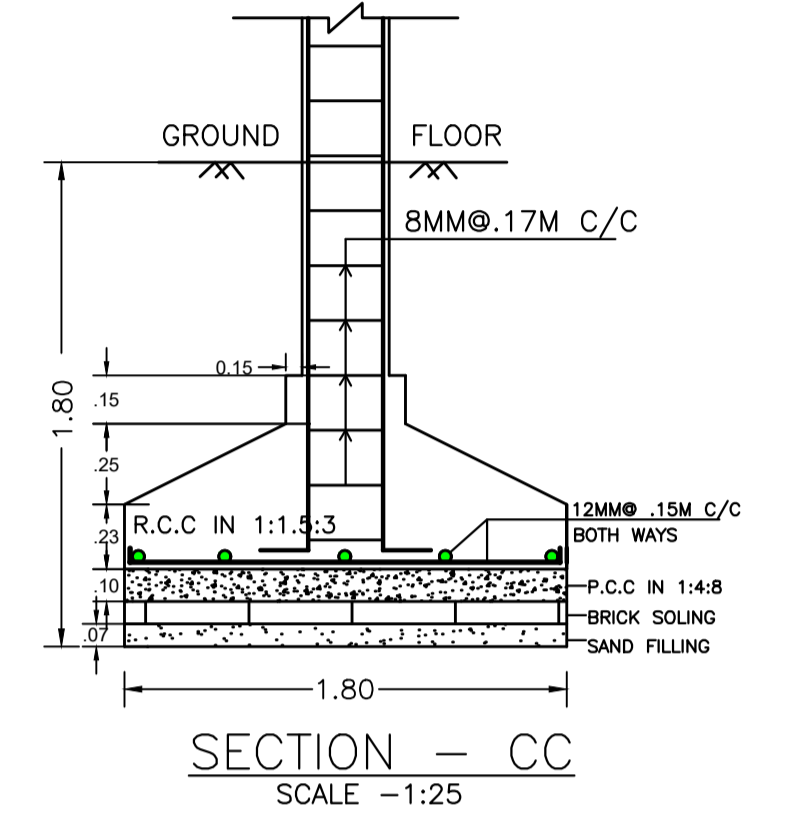
