Deed of Disclaim.

1st Party:- Joyram Majhi son of late Khara Majhi, by caste Santhal, by occupation cultivation, resident of Pardih, Tola Bamangora, P.S.Mango, Pargana Dhalbhum, District Singbhum.

2nd Party:- Nazra Khaton wife of S.M.Masquoor Ahmad, by faith Muslim, by occupation household duties, resident of Pardih, Tola Bamangora, P.S.Mango, Pargana Dhalbhum, District Singbhum.

Schedule:- In mouja Pardih, Thana No. 1641, P.S.Mango, Pargana Dhalbhum, District Singbhum, raiyati land recorded in Plot No.4436 area 0-1-5 kathas, Plot No. 4437 area 0-2-0 kathas, within Plot No. 4438 area 0-0-13 dhuls, in all 0-4-2 kathas (four kathas and two dhuls) bounded on North:- Madar Bux, South:- Mazhari, East:- Kuly Rasta, West:- Old Purulia Road.

The above lands are recorded in Old Khatian No. 6 and 8, App. Value Rs.1000-00 (One thousand). Annual rent is Rs.0.25p.

Know all men by these presents that the lands fully described in the above Schedule absolutely belong to the second party and she is in peaceful possession and enjoyment of the same in her own right without any interruption from any body since long.

Due to that wrong entry there might be unnecessary litigations and harassments between use the parties and our heirs and successors and hence by this deed of disclaim I do hereby relinquish, renounce and disclaim all my right, title and interest over the said lands and you as usual shall go on possessing and enjoying the same in your own right, title and interest by payment of annual rent Rs.0.25p to the landlord and obtaining rent receipt for the same in your own name. If any objection is raised from my side either by myself or by my heirs and successors regarding the possession and enjoyment of the same either by you or by your heirs and successors then the same will be null and void and will not be binding on you and your heirs and successors according to law.

In witness whereof I do hereunto set my hand today the 15th day of December, 1971.
