not the authority.




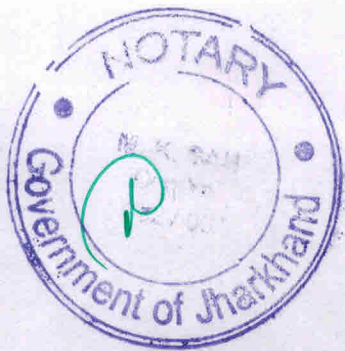



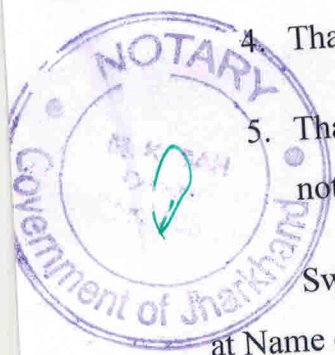
