

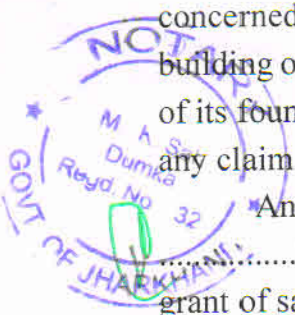
AFFIDAVIT

**INDEMNITY BOND FOR BASEMENT**

Whereas the Execution has submitted to the concerned authority the plans  
FOR basement over Plot No. (CS) 1682 Plot No.  
(MSP) 38/97 Khata No. 38/97 Holding No. 38/97  
Village/Mouza DUMKA TOWN Ward No. 16 of DUMKA NAGAR PARISHAD  
Municipal Corporation/Municipal Council/Nagar Panchayat/Municipality/Notified  
Area Committee/Regional Development Authority/Industrial Area Development  
Authority/Mineral Area Development Authority, Gram Panchayat Area covered under  
Development Plan or Planning Scheme notified under Jharkhand Municipal Act 2011,  
Jharkhand Regional Development Authority Act, 2002, Mineral Area Development  
Authority Act, Jharkhand Industrial Area Development Authority Act within the  
development plan area under the provisions of the building Bye-laws  
made hereunder whereas the concerned authority has agreed in sanction the  
aforesaid construction subject to the conditions that the owner shall indemnity the  
concerned authority in development of any loss or damage being cause to the adjoining  
building on account of the construction of the said basement either as the time of digging  
of its foundations or in the course of its construction of even thereafter and also against  
any claim of any concern thereto.



And whereas the executions has agreed to execute an indemnity bond to the  
N.P.D. affect and also to abide by the terms imposed by the concerned authority the  
grant of sanction for construction of the basement.

Now the deed witnesses:

1. That in consideration of the sanction of the plans by NAGAR PARISHAD DUMKA Authority for construction of the basement the executants undertakes that he/she shall at all times keep N.P.D. Authority free from any liability, loss or damages flowing from any injury or damage caused to the adjoining built up properties or to any persons as a consequence of the construction of at the time of digging of its foundations or during the course of its construction or at any time thereafter.
2. The owner agreed and undertakes that in the event of any claim being made by any person or persons against the concerned Authority either in respect of the sanction granted by the concerned Authority to the owner for the construction of basement or in respect of the construction or manner of construction of the basement by the owner of the consequences flowing from the said sanction the executants shall be responsible and liable and not N.P.D. Authority.



3. The executants agrees and undertake to indemnify the concerned Authority fully in respect of any amount which the concerned Authority may be required to pay to any person either by way of compensation or on any other account as a result of any claim or suit or any other proceedings concerning the sanctioning of the construction of the basement of the making there of and also in respect of the costs and expenses which the concerned Authority may incur on defending any action.
4. Without prejudice to the above undertaking the executants hereby binds itself to pay to N.P.D. Authority to the full extent any amount which is Agreed to party and as per damaged accessed by Authority may be required to pay to any person in connection with relating to or concerning the sanctioning or the basement of the making thereof.
