
the time of digging of its foundations or in the course of its construction or even thereafter and also against any concern there to.

Now the deed witnesses :-

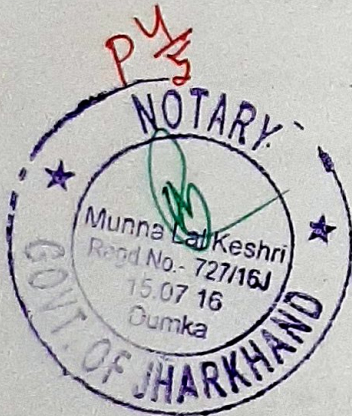



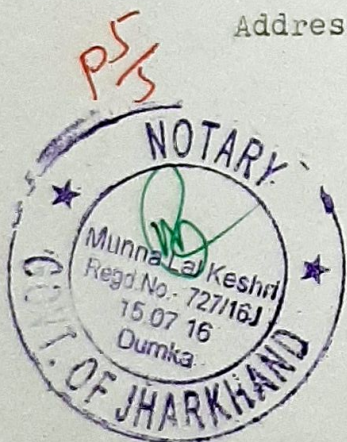
