Authority fully in respect of any amount which the concerned Authority may be required to pay to any person either by way of compensation or on any other account as result of any claim or suit or any proceedings concerning the sanctioning of the construction of the basement of the making thereof and also in respect of the costs and expenses which the concerned Authority may incur on defending any action.
- Without prejudice to the above undertaking the executants hereby binds itself to pay to Dumka Nagar Parishad Authority to the full extent any amount which Dumka Nagar Parishad Authority may be required to pay to any person in connection with relating to or concerning the sanctioning

or the basement of the making thereof. The owner agrees and undertakes that this bond shall remain in full force effect until the executants faithfully observe/ performs the undertaking ere in before contained.
