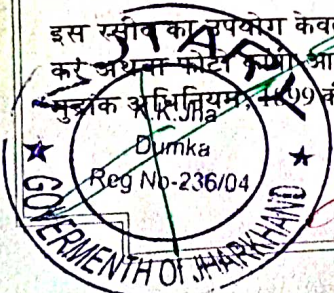

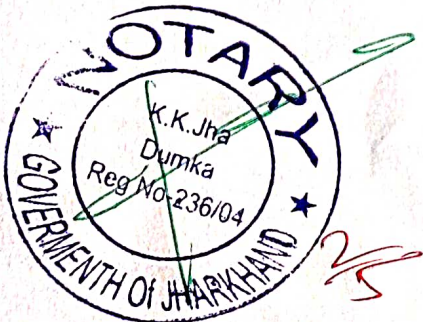

Whereas the Executant has submitted to the concerned Authority the plans for sanction of basement over Plot no. 1636 and 2247(part), Khata no. 02, Ward no. ^{OLD}(16) _{NEW-(20)} corresponding to Holding no. 0160000681000A4, measuring an area of 01 Bigha 03 Katha 12 Dhur situated at Thana Road Dumka, Mouza- Dumka Town, P.S.- Dumka Town, District- Dumka (Jharkhand), under development plan or planning scheme notified under Jharkhand municipal act 2011, Jharkhand Regional Development Authority Act 2002, Mineral Area Development Authority Act, Jharkhand Industrial Area Development Authority Act within the Development plan area of Dumka Nagar Parishad under the provision of the Building Bye-Laws made hereunder whereas the concerned authority has agreed in section the aforesaid construction subject to the conditions that the owner shall indemnify the concerned authority in development of any loss or damage

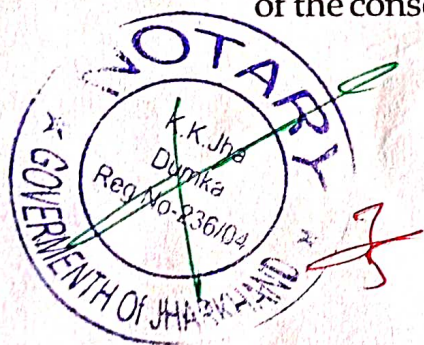

being caused to the adjoining building on account of the construction of the said basement either as the time of digging of its foundations in the course of its construction of even thereafter and also against any claim of any concern thereto.

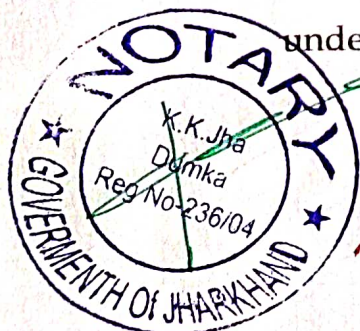
And whereas the execution has agreed to execute an indemnity bond to the Nagar Parishad Dumka Authority and also to abide by the concerned authority the grant of sanction for construction of the basement and building.

1. That in consideration of the sanction of the plans by Nagar Parishad Dumka Authority for construction of the basement the executants undertake that he/she shall at all times keep Nagar Parishad Dumka Authority free from any liability loss or damages flowing from any injury or damage caused to the adjoining built up properties or to any persons as a consequence of the construction of at the time of digging of its foundation or during the course of its construction or at any time any dispute in construction, mishappening thereafter.
2. The owner agreed and undertake that in the event of any claim being made by any person or persons against the concerned authority either in respect of the sanction granted by the concerned authority to the owner for the construction of basement or in respect of the construction or manner of construction of the basement by the owner of the consequences flowing from the said sanction the executants shall



be responsible and liable and not the Nager Parishad Dumka Authority.

3. The executant agrees and undertake to indemnity the concerned authority fully in respect of any amount which the concerned authority may be required to pay any person either by way of compensation or any other account as a result of any claim or any other proceedings concerning the sanctioning of the construction of the basement of the making thereof and also in respect of the costs and expenses which the concerned authority may incur on defending any action.
4. Without prejudice to the above undertaking the executants hereby bind itself to pay to nager parishad dumka authority to the full extent any amount which is agreed to party and as per damaged accessed by authority may be required to pay to any person in connection tith relation to or concerning the sanctioning or the basement of he making thereof.
5. The owner agrees and undertakes that this bond shall remain in full force and effect till the executant faithfully observes/performs the undertakings herein before contained.

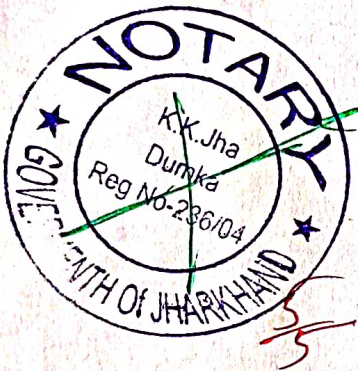
