THE DEED OF GIFT IS MADE ON THIS......DAY OF......2023 A.D.

BETWEEN

Mrs. Pushpa Devi W/O Shree Krishndev Pandey Age 45 Years By faith HINDU By Occupation, Resident of Village – Dunduriya GUMLA P.S. - Gumla, District – Gumla (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – Dunduriya GUMLA P.S. - Gumla, District – Gumla being R.S. Plot No. 665 Khata No.-10 Thana No – 44 Ward No - 02, Area 2.25 Decimal,

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has applied at Gumla Nagar Parishad, Gumla for sanctioning of building plan vide BC. Case No GUNPC/BP/0033/W02/2023

AND WHEREAS for the development or widening of road in front & side of the above mentioned land the DONOR has left a strip of land for Road Widening and is ready to donate the said strip of land to the State mentioned in Schedule below for the benefit of Society as a whole.

NOW THIS DEED OF GIFT WITNESSES AS FOLLOWS:-

That in pursuance of the said intention and in consideration of benefits to the society as whole
the DONER out of his free will, without coercion or undue influence from anybody whom so
ever hereby convey, grant, transfer and confirm unto the said DONEE - "The State "all that
strip of land measuring an area of 2.25 Decimal. Mournfully described in schedule below
and shown in RED wash in the map attached herewith forming part of this Deed.

And that the said DONEE i.e., the State shall and may from time to time and at all time, hereafter peaceable and quietly use the said strip of land as a public property and shall have liberty to construct the road etc. And that the DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
