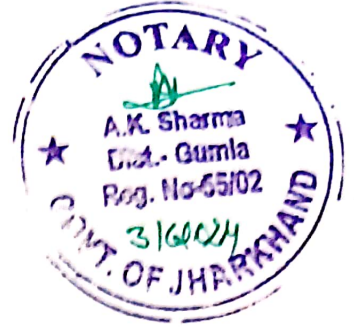

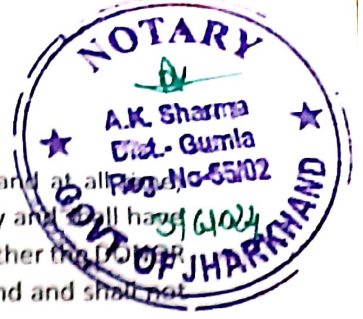
NOW THIS DEED OF GIFT WITNESSES AS FOLLOWS:-
