AND

THE EXECUTIVE OFFICER, Gumla Nage Parishad, Gumla (Hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in possession of Land, tenements and premises at Village - Good 9. District - Gumla being R/S Plot No.- 930, Khata No.- 04, Thana No.- 59...

AND WHEREAS in order to construct a building over the land mentioned herein above the DONOR has applied at Ranchi Regional evelopment Authority, Ranchi for sanctioning of building plan vide BC. Case No.- GUNPC/BP/0049/W20/2021 AND WHEREAS for the development or road widening of the road in front of the above mentioned land the DONOR has left a strip of the land for Road widening and is Ready to Donate the said strip of land to the state mentioned in schedule below for the benefit of the society as a whole.
