

Minz, Age 52 Years and (3) Irene Toppo W/O Raymond Toppo, Age 64 Years, All By faith Christian Housewife By Occupation, All Resident of Village — Pugu Nadi Toli Gumla P.S. - Gumla, District — Gumla PIN — 835207 (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.
