"GIFT DEED"

THE DEED OF GIFT IS MADE ON THIS 28 DAY OF June 2024 A.D.

BETWEEN

Mrs. Punam Pandey W/O Manoj Kumar Tiwari , Age 43 Years By faith Hindu, Business By Occupation, Resident of Village – JAWAHAR NAGAR GUMLA P.S. - Gumla, District – Gumla PIN – 835207 (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village –JAWAHAR NAGAR GUMLA , PO and PS GUMLA DISTT GUMLA being R.S. Plot No. 938 Khata No.- 83 Thana No – 59, Ward No - 20 , Area 3.00 Decimal,

And that the said DONEE i.e., the State shall and may from time to time and at all time, hereafter peaceable and quietly use the said strip of land as a public property and shall have liberty to construct the road etc. And that the DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
