BETWEEN

Mrs. Nemhan Minz Wife of Saihun Ekka Age 60 Years By faith Christian Housewife By Occupation, Resident of Village – Palkot Road Gumla P.S. - Gumla, District – Gumla PIN – 835207 (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.
