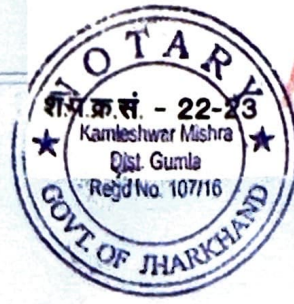

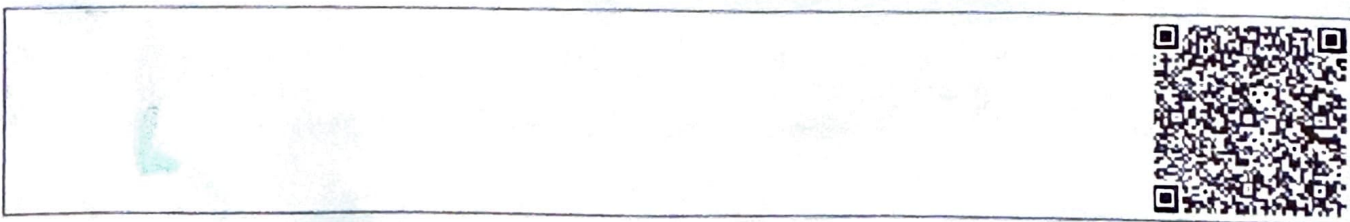

THE DEED OF GIFT IS MADE ON THIS 28 DAY OF June 2024 A.D.

BETWEEN

Mr. Muneshwar Sahu S/O Jagmohan Sahu, Age 40 Years By faith Hindu, Business By Occupation, Resident of Village – JAWAHAR NAGAR GUMLA P.S. - Gumla, District – Gumla PIN – 835207 (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – JAWAHAR NAGAR GUMLA , PO and PS GUMLA DISTT GUMLA being R.S. Plot No. 930 Khata No.- 4 Thana No – 59 Ward No - 20 , Area 3.00 Decimal,
