### AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – CHETAR GUMLA P.S. - Gumla, District – Gumla PIN – 835207 being R.S. Plot No. 731 Khata No.- 92 Thana No – 47 Ward No - 4, Area 10 Decimal,
