Mrs. USHA SANI Wife of Suresh Soni Years - 66 By faith HINDU Business By Occupation, Resident of Village – DUNDURIYA GUMLA P.S. - Gumla, District – Gumla PIN – 835207 (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – DUNDURIYA GUMLA P.S. - Gumla, District – Gumla PIN – 835207 being R.S. Plot No. 397 Khata No.- 110 Thana No – 44 Ward No - 2, Area 2 Decimal,
