By faith By Occupation, Resident of Village –MURLI BAGICHA Gumla P.S. - Gumla, District - Gumla (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – MURLI BAGICHA Gumla , P.S. - Gumla, PS NO – 59, District - Gumla, being R.S. Plot No. 886 Khata No.- 430 Ward No- 17 Area 09 Decimal

And that the said DONEE i.e., the State shall and may from time to time and at all time, hereafter peaceable and quietly use the said strip of land as a public property and shall have liberty to construct the road etc. And that the DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.

IN WITNESS whereof the said DONOR has hereto set and subscribed his signature and delivered in the presence of witnesses as present day, month and year above mentioned.

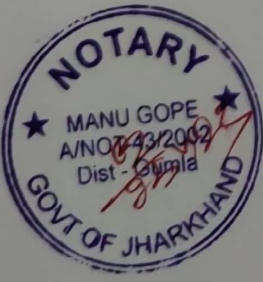
