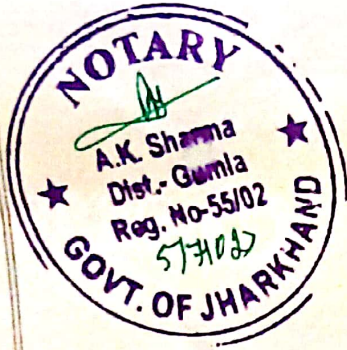

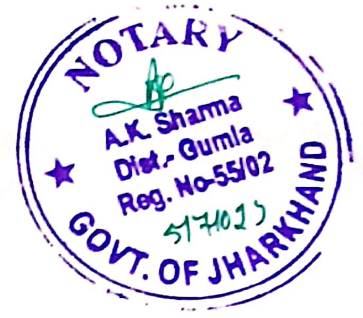

BETWEEN

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – Jawahar Nagar GUMLA P.S. - Gumla, District – Gumla Gumla, P.S. - Gumla, District - Gumla, being R.S. Plot No. 914 Khata No.- 96 Ward No - 20, Thana No – 59 Area 02 Decimal,

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has applied at Gumla Nagar Parishad, Gumla for sanctioning of building plan vide BC. Case No GUNPC/BP/0030/W20/2023

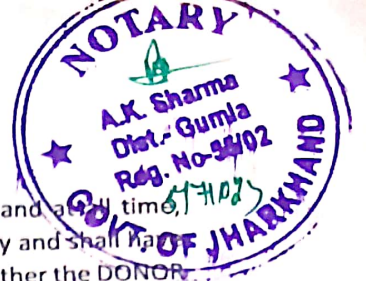

And that the said DONEE i.e., the State shall and may from time to time and at any time hereafter peaceable and quietly use the said strip of land as a public property and shall have liberty to construct the road etc. And that the DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
