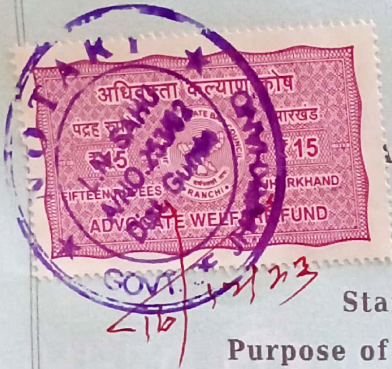

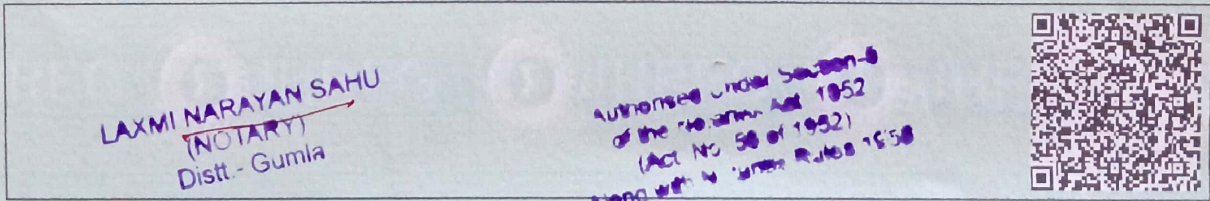

Resident of Village – RASHMI NAGAR SISAI ROAD GUMLA P.S. - Gumla, District – Gumla PIN - 835207  
(hereinafter called the DONOR) of the ONE PART.

**AND**

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

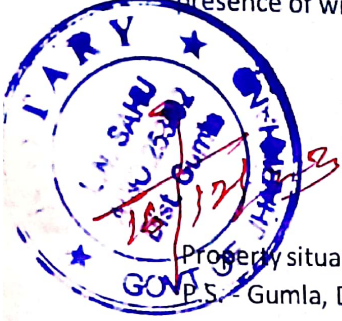
