

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village - Shanti Nagar Gumla, P.S.- Gumla, District - Gumla, being R.S. Plot No.- 1370, Khata No.- 44, Thana No.- 59, Ward No.- 11, Area 10 Decimal.

And that the said DONEE i.e.., the State shall and may from time to time and at all time, hereafter peaceable and quietly use the said strip of land as a public property and shall have liberty to construct the road etc. And that the DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right, title or interest over the schedule land ad shall not encroach the said strip of land.
