No.- 11, Area 10 Decimal.

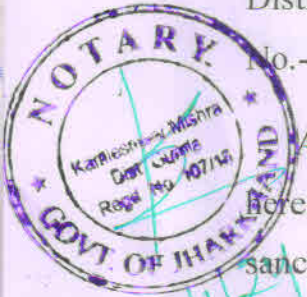
AND WHEREAS in the order to construct a building over the land mentioned


