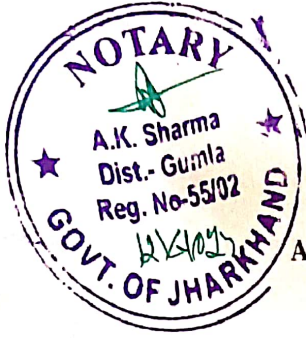

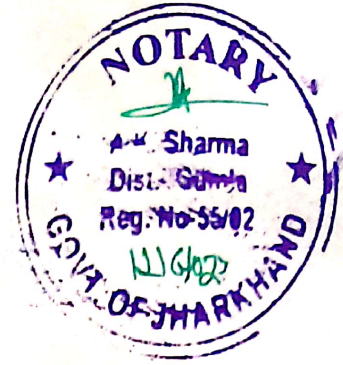

BETWEEN

KUSUM TIRKEY WIFE OF EUJIN TIRKEY Both By faith Christian By Occupation, Resident of Village -SISAI ROAD NORTH DUMERTOLI P.S. - Gumla, District - Gumla (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – SISAI ROAD NORTH DUMERTOLI P.S. - Gumla, District – Gumla , being R.S. Plot No. 1129 Khata No.- 60 Ward No- 09 area 12 Decimal

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has applied at Gumla Nagar Parishad, Gumla for sanctioning of building plan vide BC. Case No GUNPC/BP/0020/W09/2021/ALT2

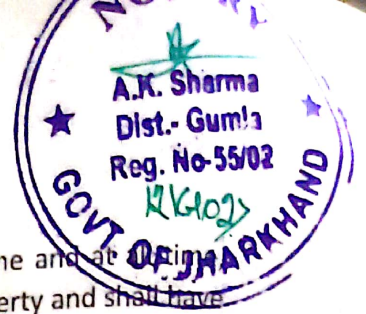

And that the said DONEE i.e., the State shall and may from time to time and at all times hereafter peaceable and quietly use the said strip of land as a public property and shall have liberty to construct the road etc. And that the DONOR hereby declares that neither the DONOR nor his legal heirs shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
