

BETWEEN

KUSUM TIRKEY WIFE OF EUJIN TIRKEY Both By faith Christian By Occupation, Resident of Village –SISAI ROAD NORTH DUMERTOLI P.S. - Gumla, District - Gumla (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – SISAI ROAD NORTH DUMERTOLI P.S. - Gumla, District – Gumla, being R.S. Plot No. 1129 Khata No. - 60 Ward No - 09 area 12 Decimal

AND WHEREAS in the order to construct a building over the land mentioned herein above the DONOR has applied at Gumla Nagar Parishad, Gumla for sanctioning of building plan vide BC. Case No GUNPC/BP/0020/W09/2021/ALT2

AND WHEREAS for the development or widening of road in front & side of the above mentioned land the DONOR has left a strip of land for Road Widening and is ready to donate the said strip of land to the State mentioned in Schedule below for the benefit of Society as a whole.
