BETWEEN

Mrs. ARCHANA KUMARI W/O SHREE SUNIL EKKA Age 35 Years By faith By Occupation, Resident of Village – DUNDURIYA GUMLA P.S. - Gumla, District – Gumla PIN - 835207 (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – DUNDURIYA GUMLA P.S. - Gumla, District – Gumla PIN - 835207being R.S. Plot No. 393 Khata No. - 2 Thana No – 44 Ward No - 02, Area 7.00 Decimal,
