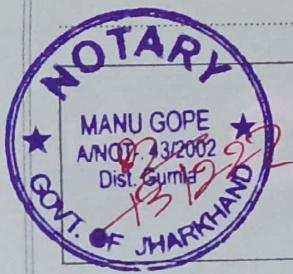

Resident of Village – DUNDURIYA GUMLA P.S. - Gumla, District – Gumla PIN - 835207 (hereinafter  
called the DONOR) of the ONE PART.

### AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER  
PART.
