BETWEEN

Mrs. SEEMA PRAJAPATI W/O SHREE VISHESHWAR MAHTO Age 47 Years By faith HINDU By Occupation, Resident of Village – CHETAR GUMLA P.S. - Gumla, District – Gumla (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in Possession of land, Tenement and premises situated at Village – CHETAR GUMLA P.S. - Gumla, District – Gumla being R.S. Plot No. 465 Khata No.- 11 Thana No – 47 Ward No - 04, Area 10.00 Decimal,
