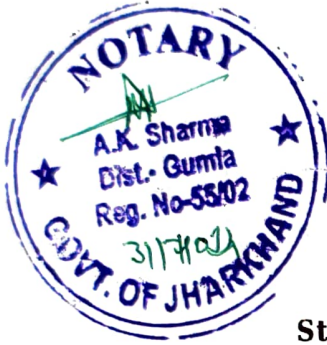

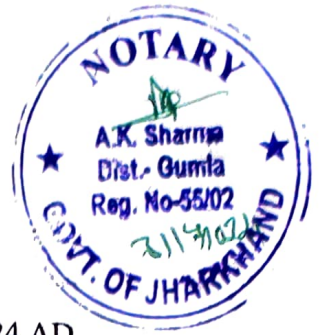

### **BETWEEN**

Balmati Devi, W/o Dr. Bharat Sahu, Age 62 years, and Minu Kumari, W/o – Sri Anup Kumar, Age 35 years, by faith Hindu, belong to Teli BC-I Community, resident of Village Veer Kunwar Singh colony Gumla, P.S- Gumla, Dist. – Gumla (hereinafter called the DONOR) of the One PART  
AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in possession of land, Tenement and premises situated at Village Gumla, P.S- Gumla, District – Gumla, being R.S/M.S Plot No. 737 Khata No. 230 Ward No. – 18 area .....<sup>161.93</sup> Sqm.

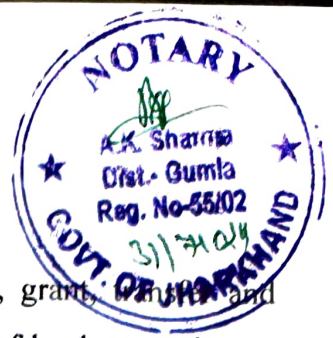

2. And that the said DONEE i.e., the State shall and may from time to time and at all time, hereafter peaceable and quietly use the said strip of land as a public property and shall have liberty to construct the road etc. and that the DONOR hereby declares that neither the DONOR nor her legal heirs shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
