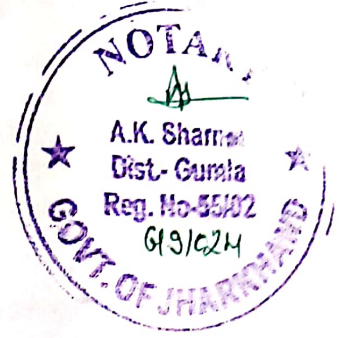

BETWEEN

Mr. Sanjay Kumar Kesari Son of Chhedi Sahu Age 59 Years By faith Hindu Business By Occupation, Resident of Village – Bank Colony , Dunduriya, P.S. - Gumla, District – Gumla PIN – 835207 (hereinafter called the DONOR) of the ONE PART.

AND

THE EXECUTIVE OFFICER, Gumla Nagar Parishad, Gumla (hereinafter called the DONEE) of the OTHER PART.

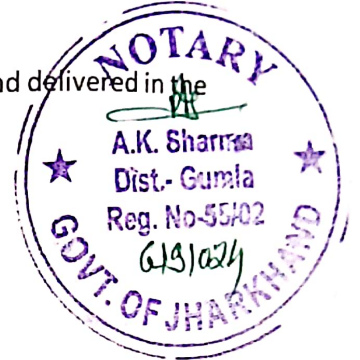
