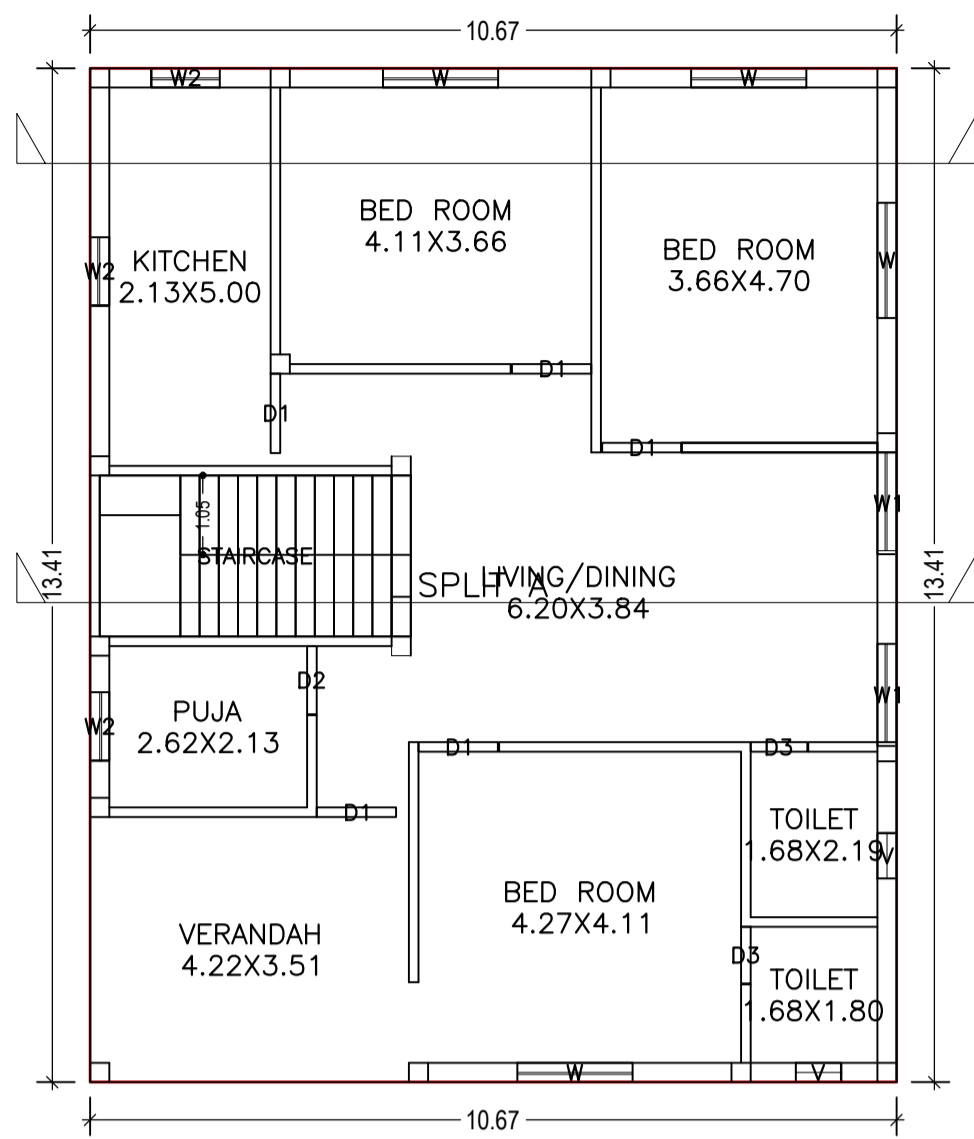

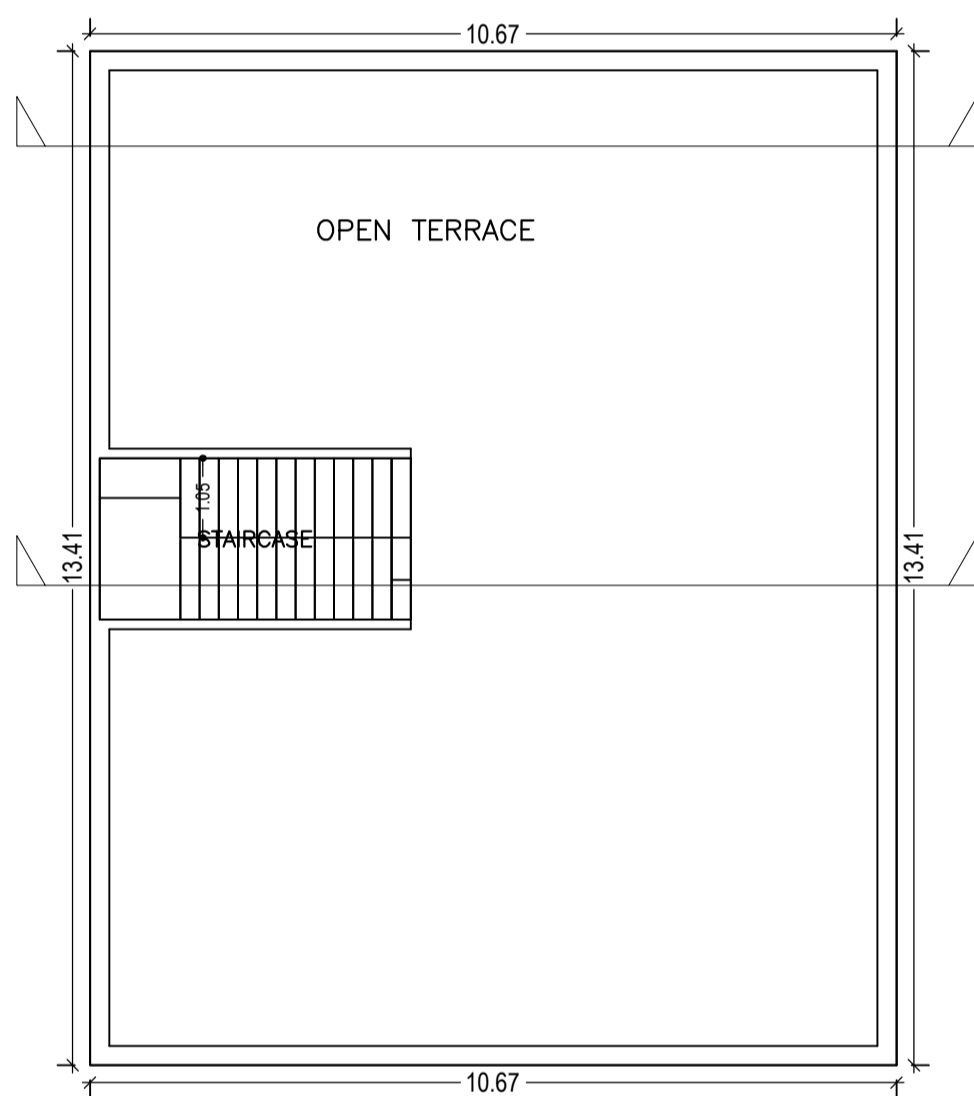

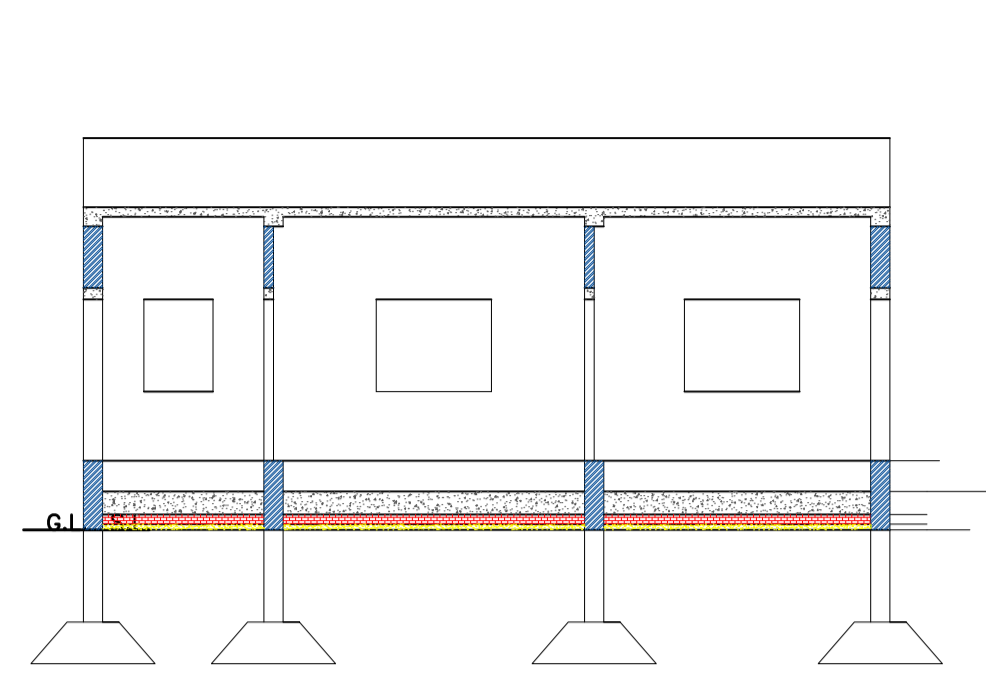

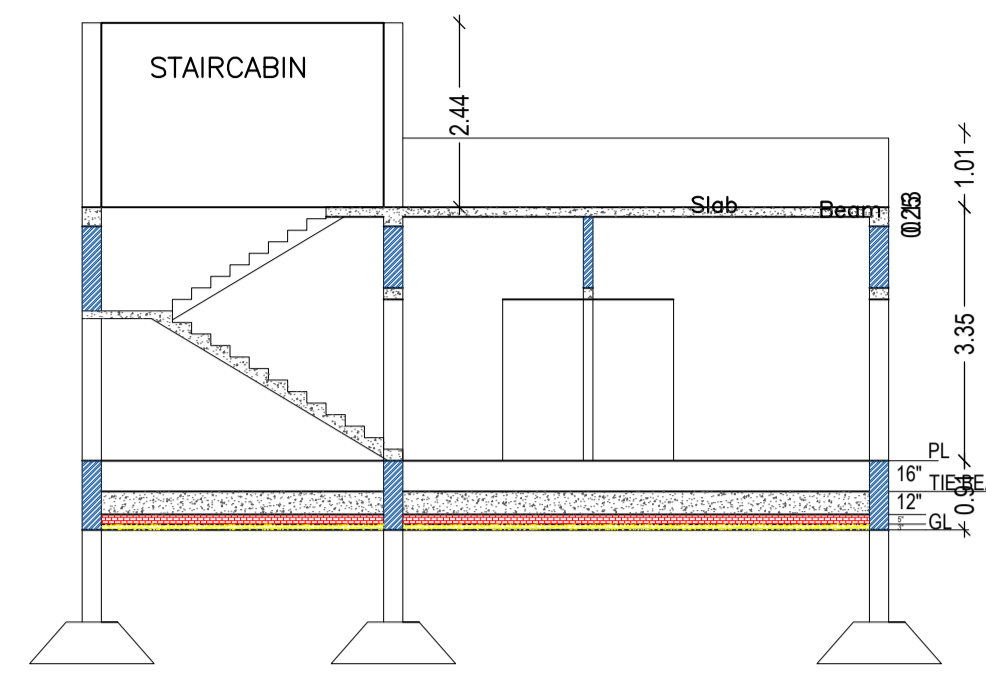
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)



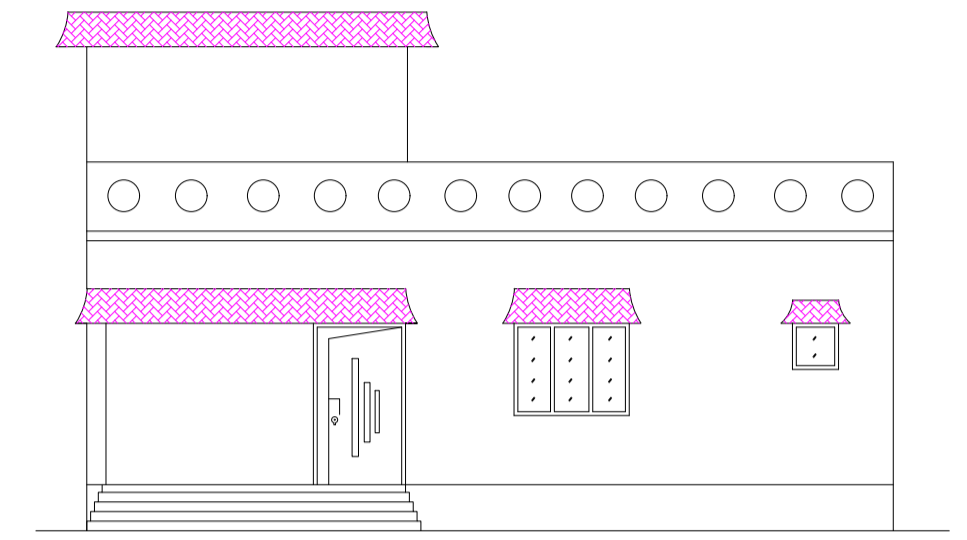
TERRACE FLOOR PLAN (SCALE 1:100)



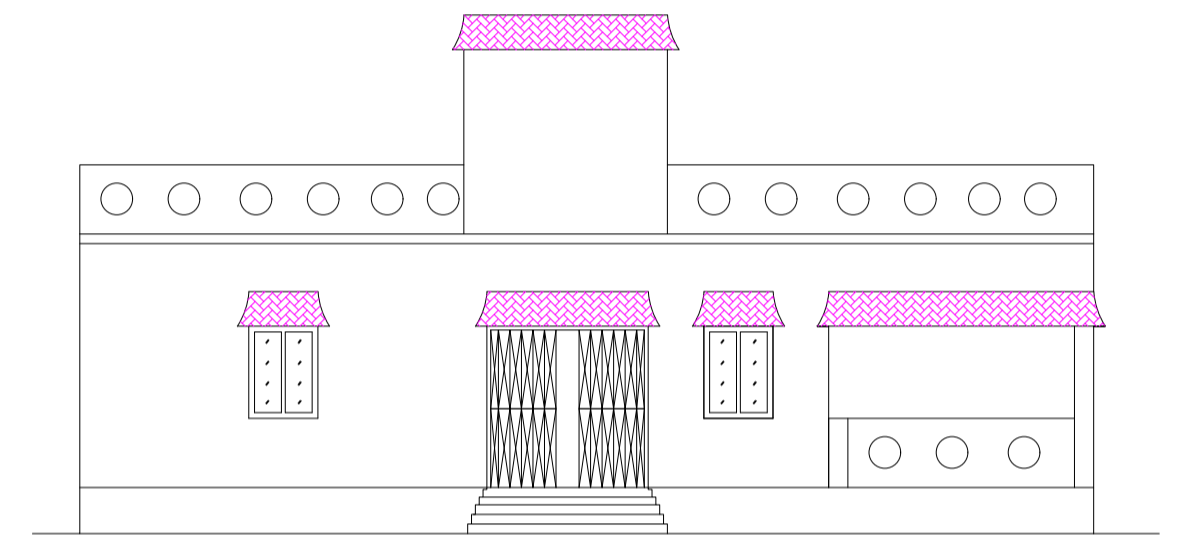
CROSS SECTION (B)



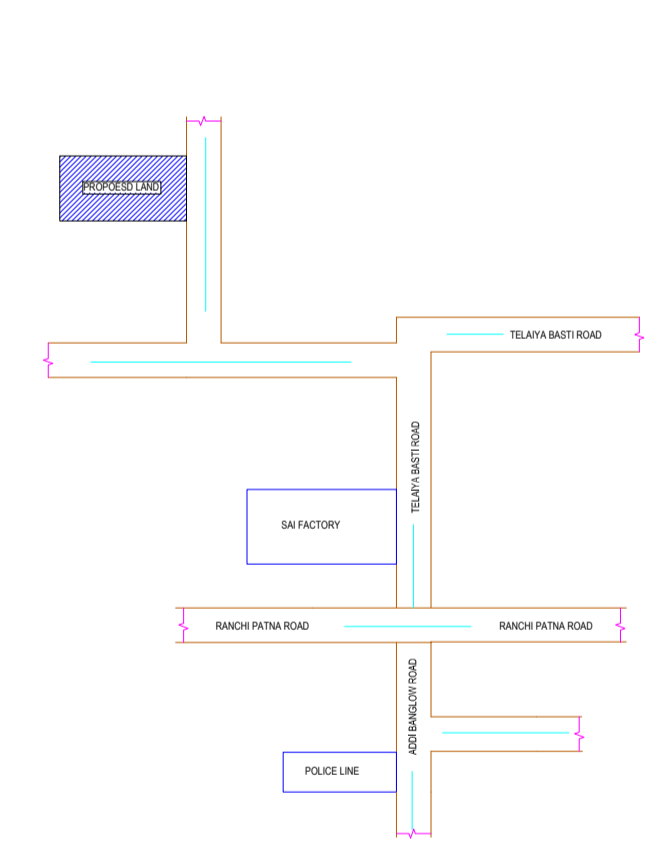
CROSS SECTION (A)



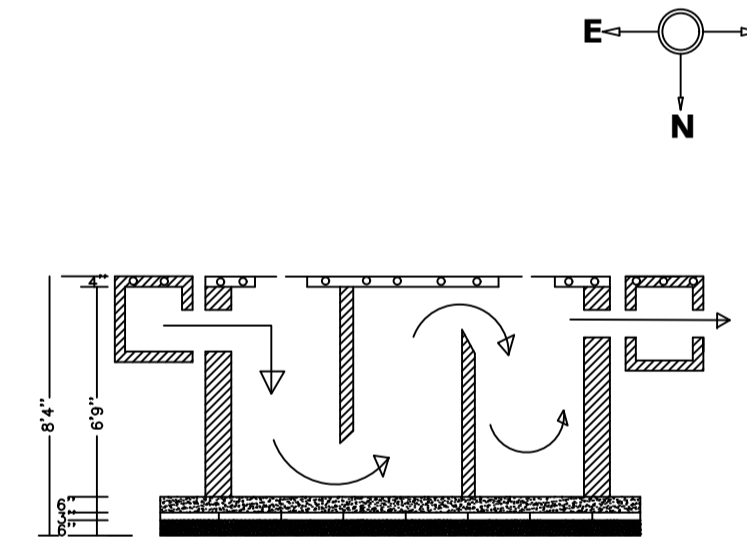
FRONT ELEVATION



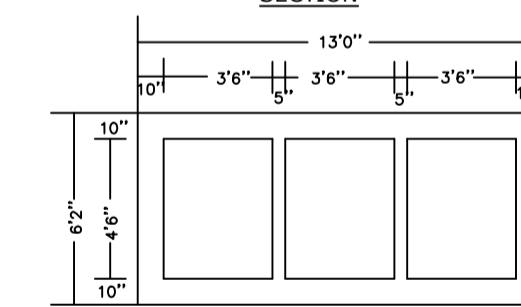
CROSS ELEVATION



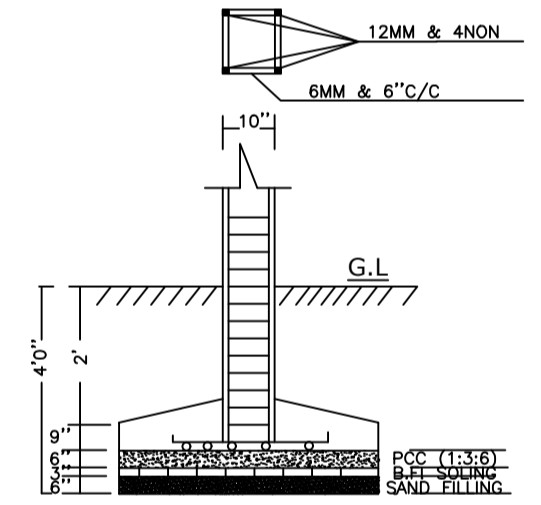
LOCATION PLAN (SCALE -1"=16')



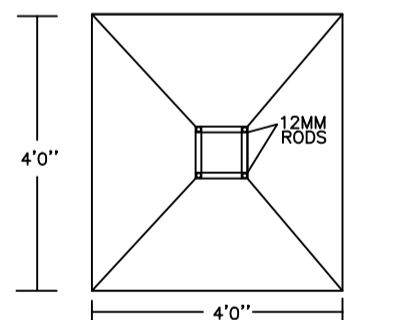
