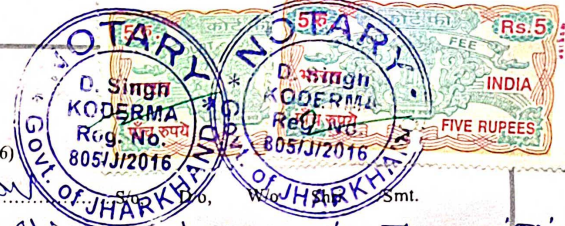

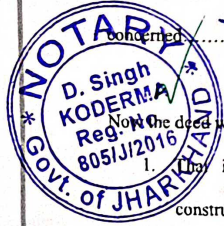
The indemnity Bond is executed by Shri/ Smt. Jagshikhar Yadav,

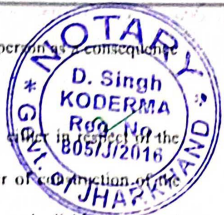

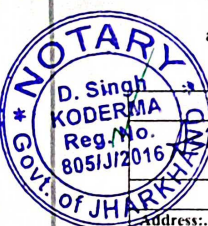
