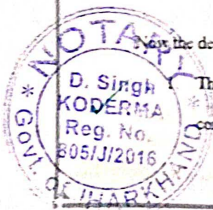

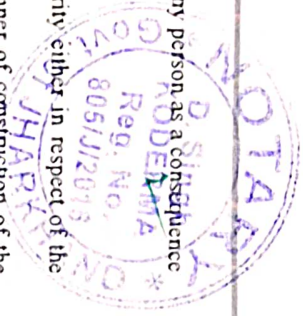
basement by the owner of the consequences flowing from the said sanction the executant shall be responsible and liable and not
