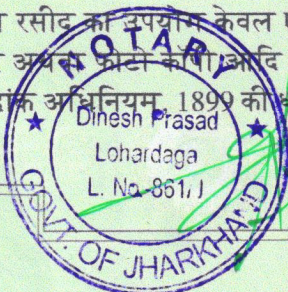

**BASIYO DEVI W/O JAGJIWAN BHAGAT**, By faith – ST, Residence of Village- **KUMHAR TOLI S.G. PATH**, P.S.-Lohardaga, District- Lohardaga, Jharkhand, (Called the DONOR) of the one PART

**AND**

**LOHARDAGA NAGAR PARISHAD** , (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in possession of land, Tenements and premises situated at Village - **KUMHAR TOLI S.G. PATH**, P.S.- **Lohardaga** , District - **Lohardaga**, being R.S. Plot No.-**79/130**, Khata No.- **04**, Thana No:-**195**,

AND WHEREAS in order to construct building over the land mentioned herein above the DONOR has got a building plan sanctioned by the **LOHARDAGA NAGAR PARISHAD** ,

Vide BC. Case NO. - **LNP/BP/0019/W08/2023**,

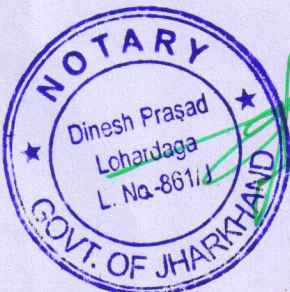

2. And That the said DONEE i.e. the state shall and may from time to time and at all times hereafter peaceably and quietly use the said strip of land as a public property and shall have liberty to construct the road etc.

AND THAT the Donor, hereby declares that neither the DONOR nor his legal heirs, shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.

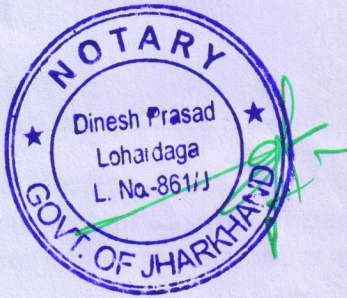
