### BETWEEN

SHRI SHAILESH TIRKEY S/O SHRI RAJEEV LOHRA, by faith HINDU, Residence of village - KISKO MORE, SHANTI NAGAR, Thana LOHARDAGA and District- LOHARDAGA (Here in after called the owner) of the one part.

#### AND

The State of Jharkhand, through the Governor of the state at the Ranchi (Here in after called the donor) of the other part.

Whereas, the said downer is the absolutes owner in possession of land, tenements and premises situated at village KISKO MORE, SHANTI NAGAR, WARD NO 05, Distrist- Lohardaga begging R.S plot no.:- 973 & 993, Khata no:- 192 & 48, Thana no:- 141. (Detailed of land).

And Whereas in order to construct a building over a land mentioned herein above the donor has got a building plan sanctioned by the Lohardaga nager parsad vide B.C case no. LNP/BP/0050/W05 /2019. and whereas for the development and widening of road in front of the above mentioned land the donor has left a strip of land for road/widening and is ready to donate the said strip of land the state mentioned in schedule below for the benefit of society as a whole.

And that the donor hereby declares that neither the donor his legal heirs, shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
