THIS DEED OF GIFT IS MADE ON THIS THE 8TH DAY OF MARCH 2022 A.D.

BETWEEN

Dani Jhunka Kujur wife of Daniel Kujur, by faith Christian, residence of village Nagratoli Madhuban, near Dutika Savitri Hospital Lohardaga, Thana Lohardaga, Distt. Lohardaga- 835302 (Hereinafter called the Owner/Doner) of the one part.

AND

The State of Jharkhand through the Governor of the State at Ranchi (Hereinafter called the Donee) of the part.

Whereas the said Donor is the absolute owner in possession of land tenements and premises situated at village Nagratoli Madhuban being R.S. Plot no. 1236, sub plot no. _____, Khata no. 361. Thana No. 194 (Details of land).

And in order to construct a Building over a land mentioned herein above the donor has got a building plan sanctioned by the Lohardaga Nagar Parishad vide B.C. case No. LNP/BP/0002/W22/2022 and whereas for the development and widening of road in front of the above-mentioned land the donor has left a strip of land for road widening and is ready to donate the said strip of land the state mentioned in schedule below for the benefit of the society aqs whole

Now this deed of Gift witnesses as follows-

- 1) That in pursuance of the said intention and in consideration of benefits to the society as whole the donor out of his free will without coercion or undue influence from anybody whomsoever hereby convey, grant transfer and confirm into the said done "The State" all that strips of land measuring an area of 12.86 sq. mts. more fully described in schedule.
- 2) And that the said DONEE i.e., the State shall and may from time to time and at all times hereafter peaceably and quietly use the said strip of land as a public property and shall have liberty to construct the road etc.
