THE DEED OF IS MADE ON THIS THE 13TH DAY OF SEP 2022 AD.

BETWEEN

DEWASHISH KUMAR & VISHAL KUMAR S/O LATE RADHA PRASAD by faith HINDU, Residence of village RAJA BANGLA JURIYA ROAD, LOHARDAGA , Thana LOHARDAGA and District- LOHARDAGA (Here in after called the owner) of the one part.

AND

The State of Jharkhand, through the Governor of the state at the Ranchi (Here in after called the donor) of the other part.

Whereas, the said downer is the absolutes owner in possession of land, tenements and premises situated at village- RAJA BANGLA JURIYA ROAD LOHARDAGA Distrist- Lohardaga bearing R.S/M.S plot no.- 727/728 Khata no.- 276 Thana no,- 194, (Detailed of land).

And Whereas in order to construct a building over a land mentioned herein above the donor has got a building plan sanctioned by the Ranchi municipal corporation vide B.C case no.- LNP/BP/0073/W14/2021. and where as for the development and widening of road in front of the above mentioned land the donor has left a strip of land for road/widening and is ready to donate the said strip of land the state mentioned in schedule below for the benefit of society as a whole.

Now this deed of Gift witnesses as follow:-
