THE DEED OF GIFT IS MADE ON THIS THEDAY OF...... JULY, 2022, A.D.

BETWEEN

RAKHI DEVI W/O PRADEEP KUMAR TAMERA, By faith – Hindu, Residence of Village-NAWARI PARA P.S.-Lohardaga, District- Lohardaga, Jharkhand, (Called the DONOR) of the one PART

AND

LOHARDAGA NAGAR PARISHAD, (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in possession of land, Tenements and premises situated at Village - NAWARI PARA, P.S.- Lohardaga, District -Lohardaga, being R.S. Plot No.-428, Khata No.- 205, Thana No:-194,

AND WHEREAS in order to construct building over the land mentioned herein above the DONOR has got a building plan sanctioned by the LOHARDAGA NAGAR PARISHAD,

Vide BC. Case NO. - LNP/BP/0035/W20/2022,

AND WHEREAS for the development or widening of road in front & side of the above mentioned land the DONOR has left a strip of land for Road/Widening and is ready to Donate the said strips of land to the State mentioned in schedule below for the benefit of society as a whole.

NOW THIS DEED OF GIFT WITNESSES AS FOLLOWS:-

- 1. That in pursuance of the said intention and in consideration of benefits to the society as whole the DONOR out of his free will, without coercion or undue in fluence from anybody whom so ever here by convey, grant transfer and confirm unto the side DONEE "The State" all that strip of land measuring an area of 12 SOM. More fully described in schedule.
- 2. And That the said DONEE i.e. the state shall and may from time to time and at all times hereafter peaceably and quietly use the said strip of land as a public property and shall have liberty to construct the road etc.

AND THAT the Donor, hereby declares that neither the DONOR nor his legal heirs, shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
