P.S.-Lohardaga, District- Lohardaga, Jharkhand, (Called the DONOR) of the one PART

**AND**

**LOHARDAGA NAGAR PARISHAD** , (hereinafter called the DONEE) of the OTHER PART.

WHEREAS the said DONOR is the absolute owner in possession of land, Tenements and premises situated at Village - **BARWA TOLI, LOHARDAGA** , P.S.- **Lohardaga** , District - **Lohardaga**, being Plot No.-**3052**, Khata No.-**00**, Thana No:-**194**,

Vide BC. Case NO. - **LNP/BP/0043/W22/2024**,

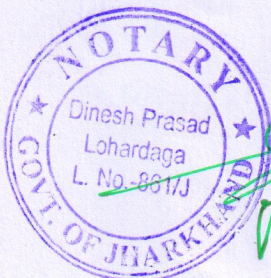

AND THAT the Donor, hereby declares that neither the DONOR nor his legal heirs, shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.

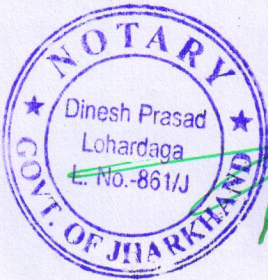
