NEMHAS TIRKEY S/O. SAMEL TIRKEY, By faith –, Residence of Village- **KAIMO PATRA TOLI P.S.-Lohardaga**, District- **Lohardaga**, Jharkhand, (Called the **DONOR**) of the one **PART**

AND

LOHARDAGA NAGAR PARISHAD , (hereinafter called the **DONEE**) of the **OTHER PART**.

WHEREAS the said **DONOR** is the absolute owner in possession of land, Tenements and premises situated at Village – **Kaimo Patratoli** , P.S.- **Lohardaga** , District -**Lohardaga**, being M.S. Plot No.- **1261**, Khata No.- **319**, Thana No:-**212**,

AND WHEREAS in order to construct building over the land mentioned herein above the **DONOR** has got a building plan sanctioned by the **LOHARDAGA NAGAR PARISHAD** ,

Vide BC. Case NO. - **LNP/BP/0006/W05/2024**

AND WHEREAS for the development or widening of road in front of the above mentioned land the **DONOR** has left a strip of land for Road/Widening and is ready to Donate the said strips of land to the State mentioned in schedule below for the benefit of society as a whole.

NOW THIS DEED OF GIFT WITNESSES AS FOLLOWS :-

1. That in pursuance of the said intention and in consideration of benefits to the society as whole the **DONOR** out of his free will, without coercion or undue influence from anybody whomsoever here by convey, grant transfer and confirm unto the said **DONEE** "The State" all that strip of land measuring an area of **8.27 SQM**. More fully described in schedule.

2. And That the said **DONEE** i.e. the state shall and may from time to time and at all times hereafter peaceably and quietly use the said strip of land as a public property and shall have liberty to construct the road etc.

AND THAT the Donor, hereby declares that neither the **DONOR** nor his legal heirs, shall claim any right, title or interest over the schedule land and shall not encroach the said strip of land.
