GIFT DEED

THIS DEED OF GIFT IS MADE ON THIS THE 8th DAY OF October 2020 A.D.

Between

Manju Devi wife of Late Laldev Mahli, by faith Hindu, residence of village Sukumar, Thana Kuru Distt. Lohardaga (hereinafter called the owner) of the one part.

AND

The State of Jharkhand through the Governor of the State at Ranchi (Hereinafter called the donor) of the other part.

Whereas the said donor is the absolutes owner in possession of land tenements and premises situated at village Kutmu being R.S. Plot no. 1158 sub plot no. Khata No. 125 Thana No. 141 (Detailed of land).

And whereas in order to construct a Building over a land mentioned herein above the donor has got a building plan sanctioned by the Lohardaga Nagar Parshad vide B.C. case No. LNP/BP/0030/W05/2020 and whereas for the development and widening of road infront of the above mentioned land the donor has left a strip of land for road widening and is ready to donate the said strip of land the state mentioned in schedule below for the benefit of society as a whole

Now this deed of Gift witnesses as follows-

1) That in pursuance of the said intention and in consideration of benefits to the society as whole the donor out of his fee will without coercion or undue influence from anybody whomsoever hereby convey, grant transfer and confirm into the said done "The State" मंत्र देवी

All that stips of land measuring an area of 35.47 m.sq more fully described in schedule.

2) and that the said DONEE i.e the State shall and may from time to time and at all times hereafter peaceably and quietly use the said strip of land as a public property and shall have liberty to construct the road etc.

And that the doner herebydeclares that neither the doner his legal heirs, shall claim any right, title or interest over this schedule land shall not encroach the said strip of land.
