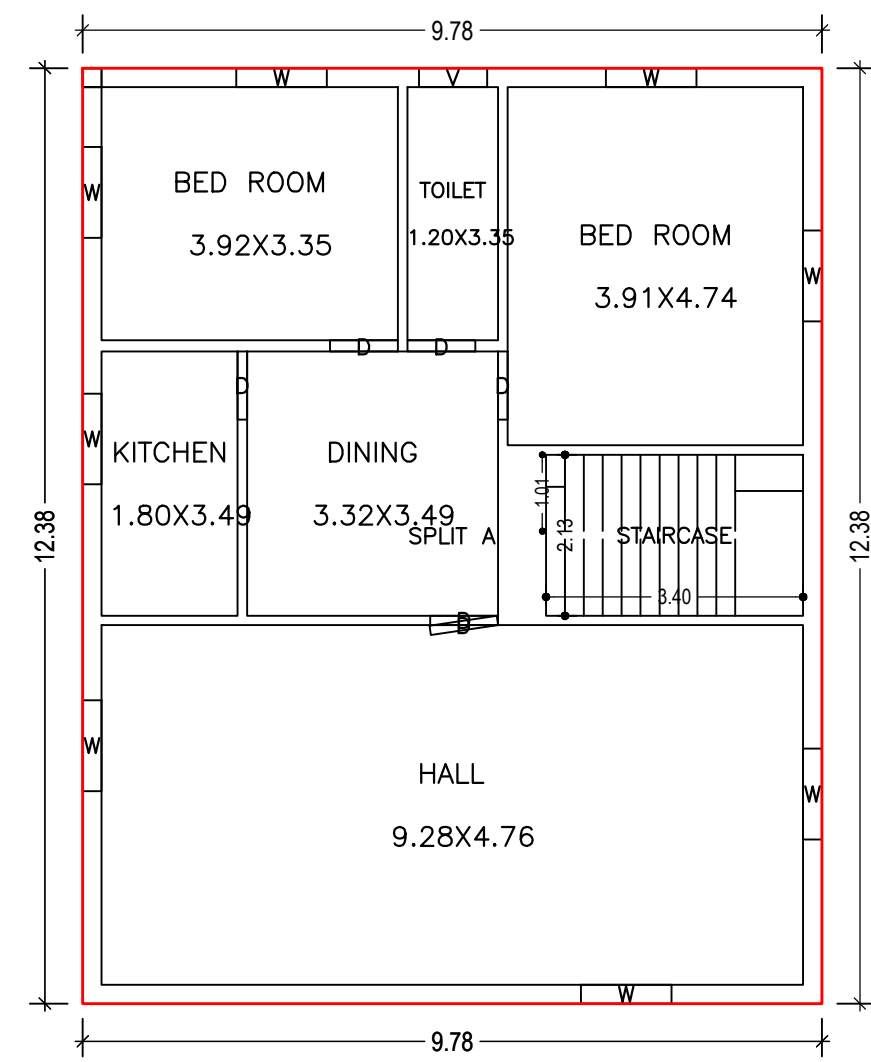

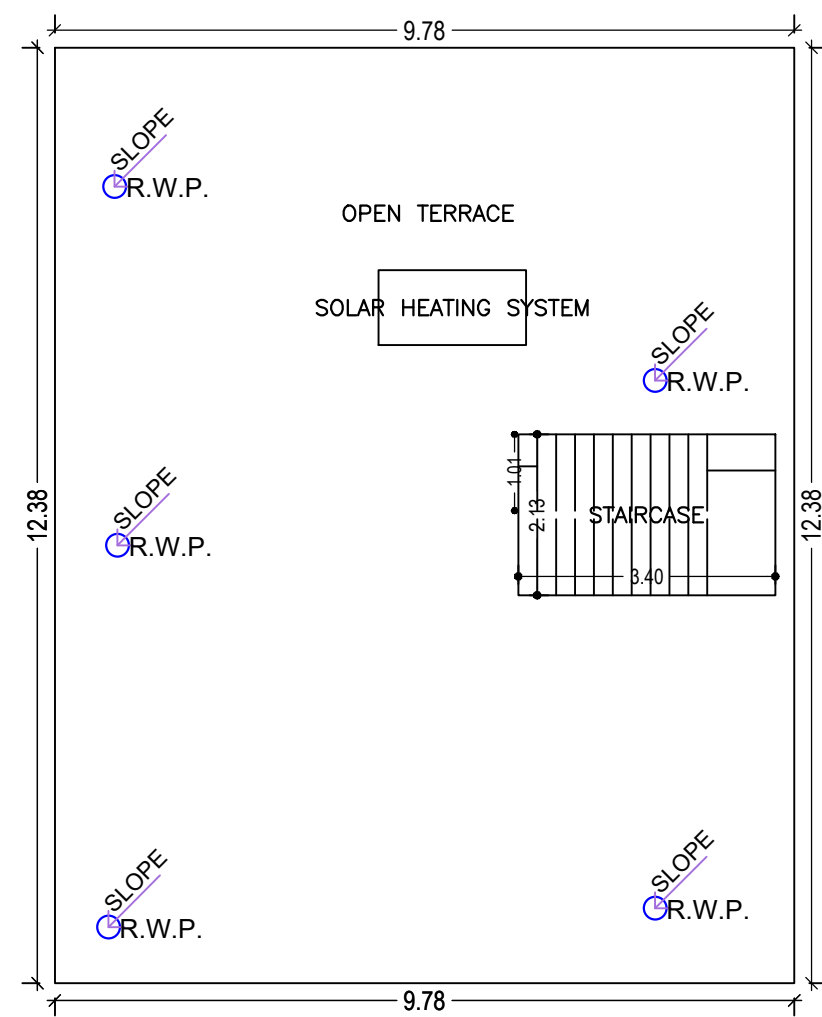

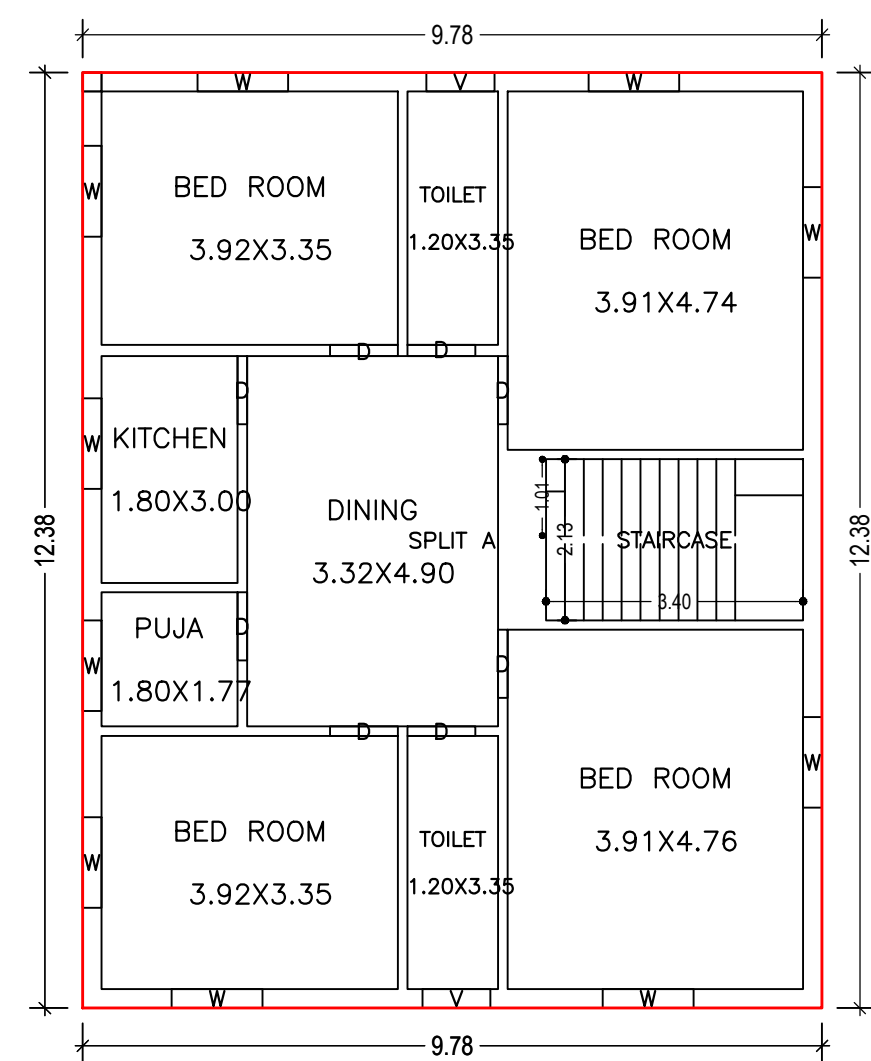

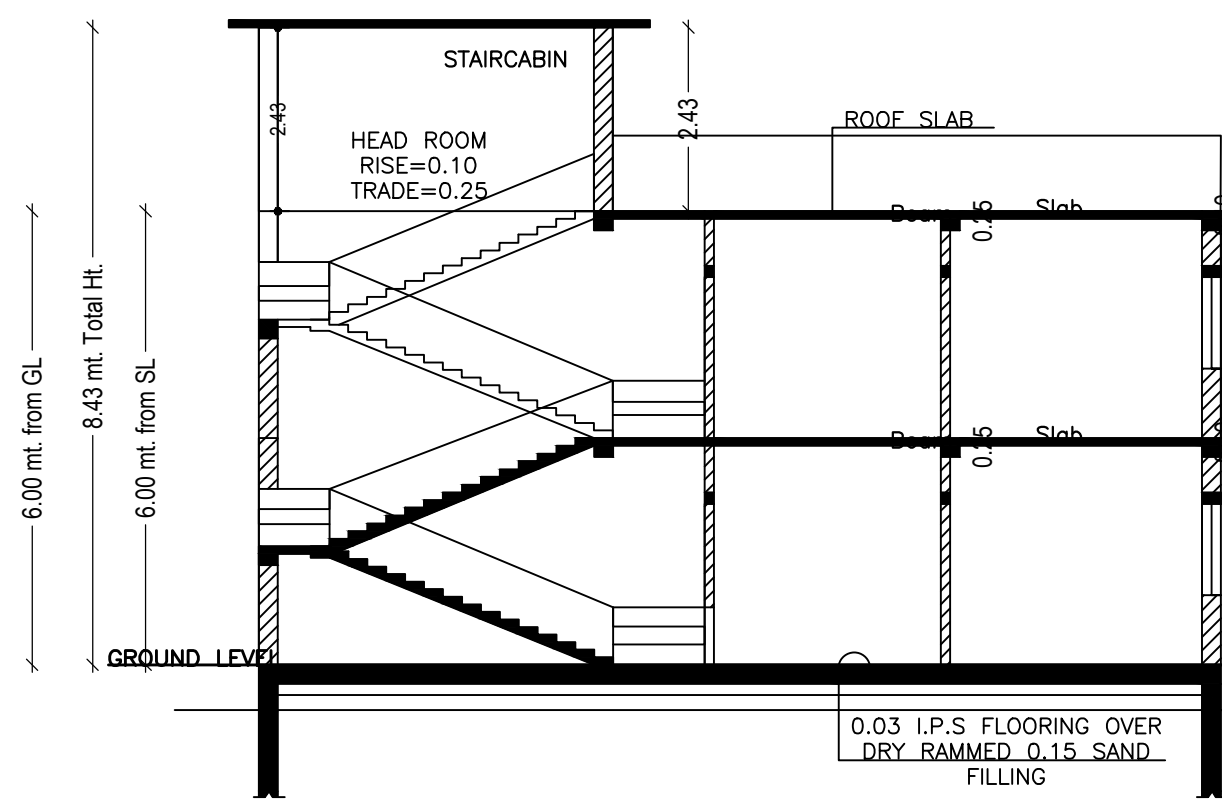
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)



TERRACE FLOOR PLAN (SCALE 1:100)

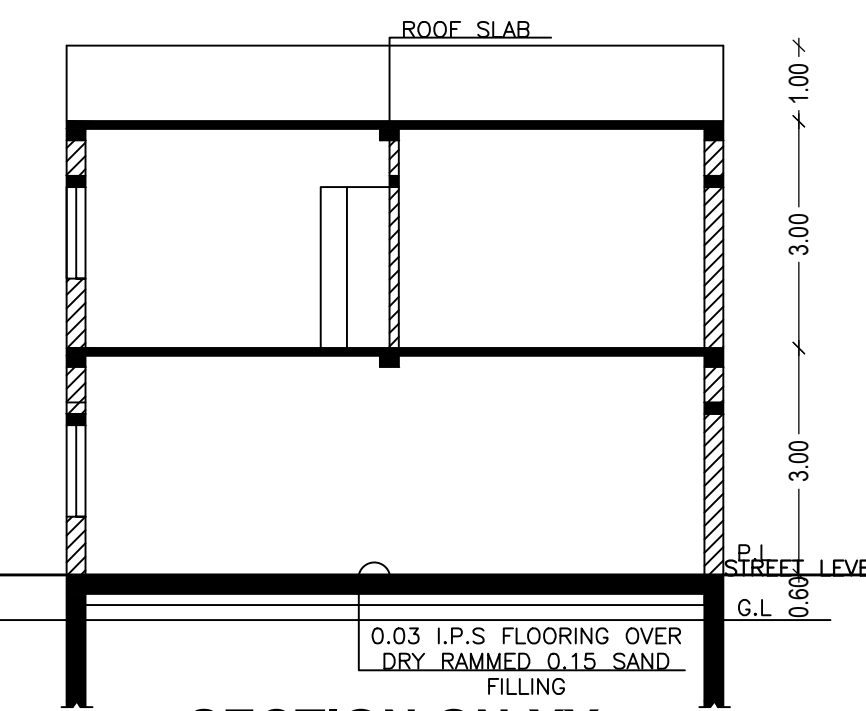

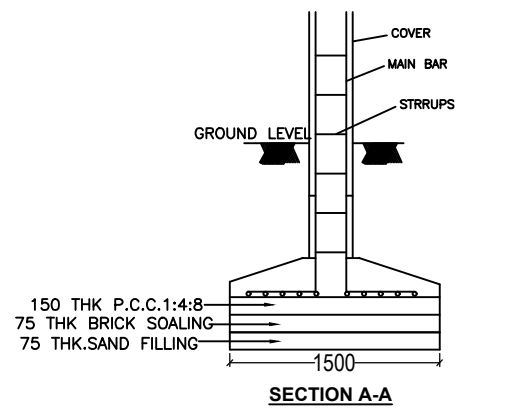
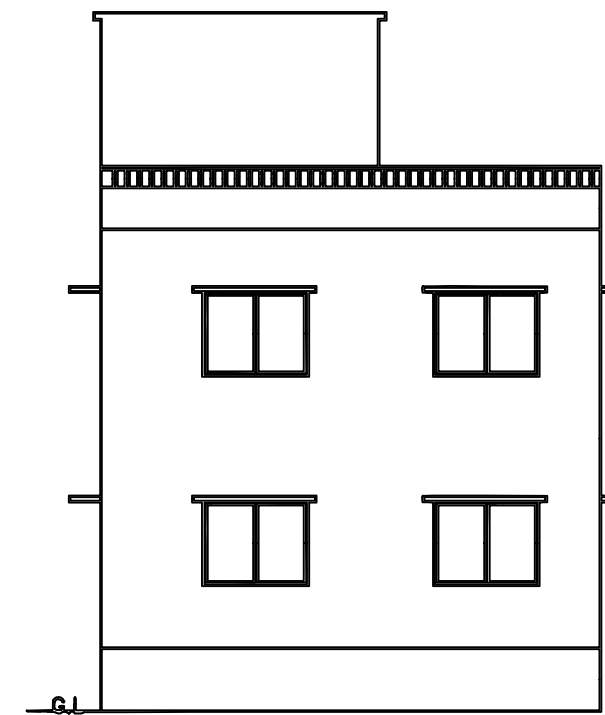

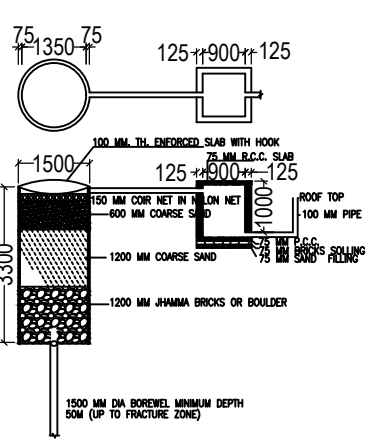
FRONT SIDE ELEVATION



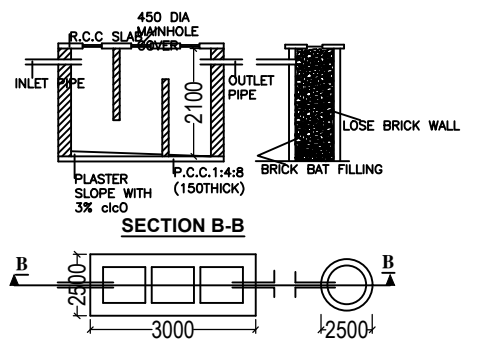

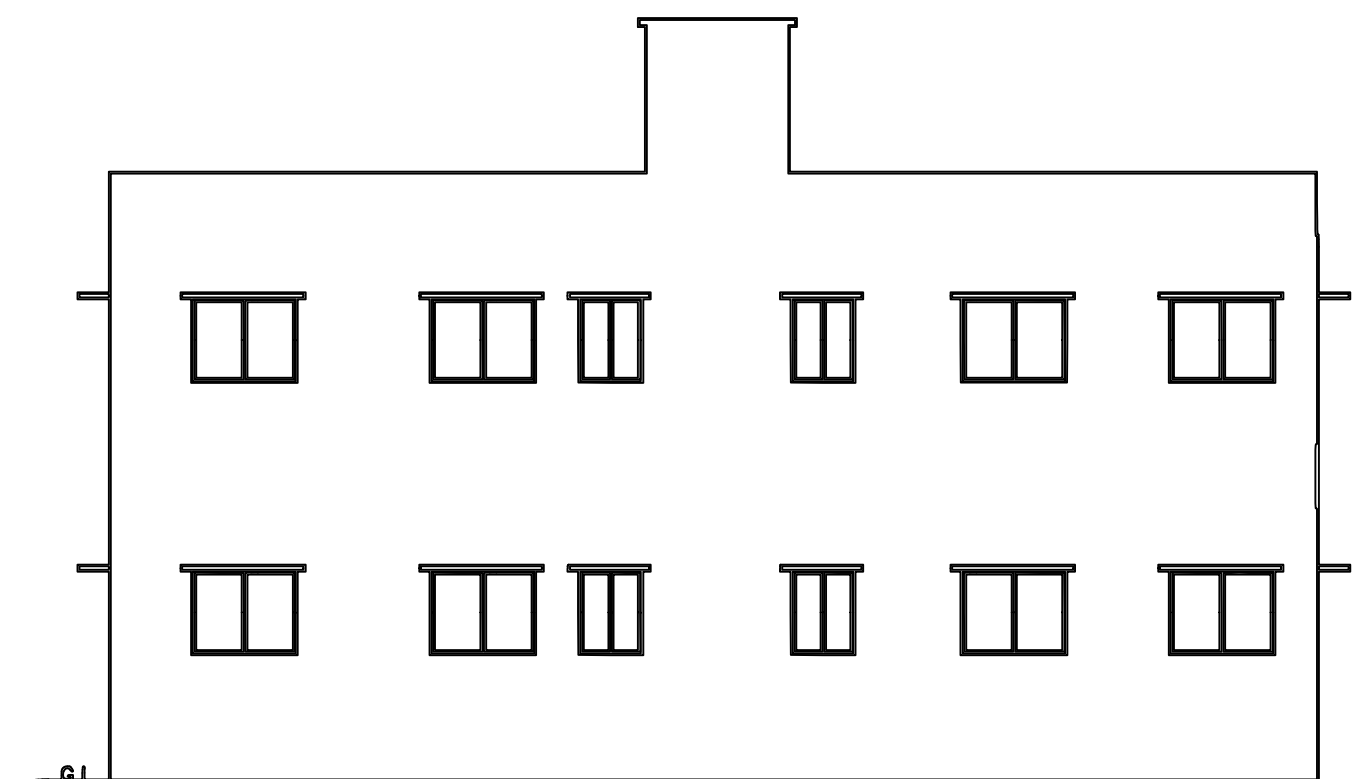
DETAIL OF FOUNDATION SCALE - N.T.S.
