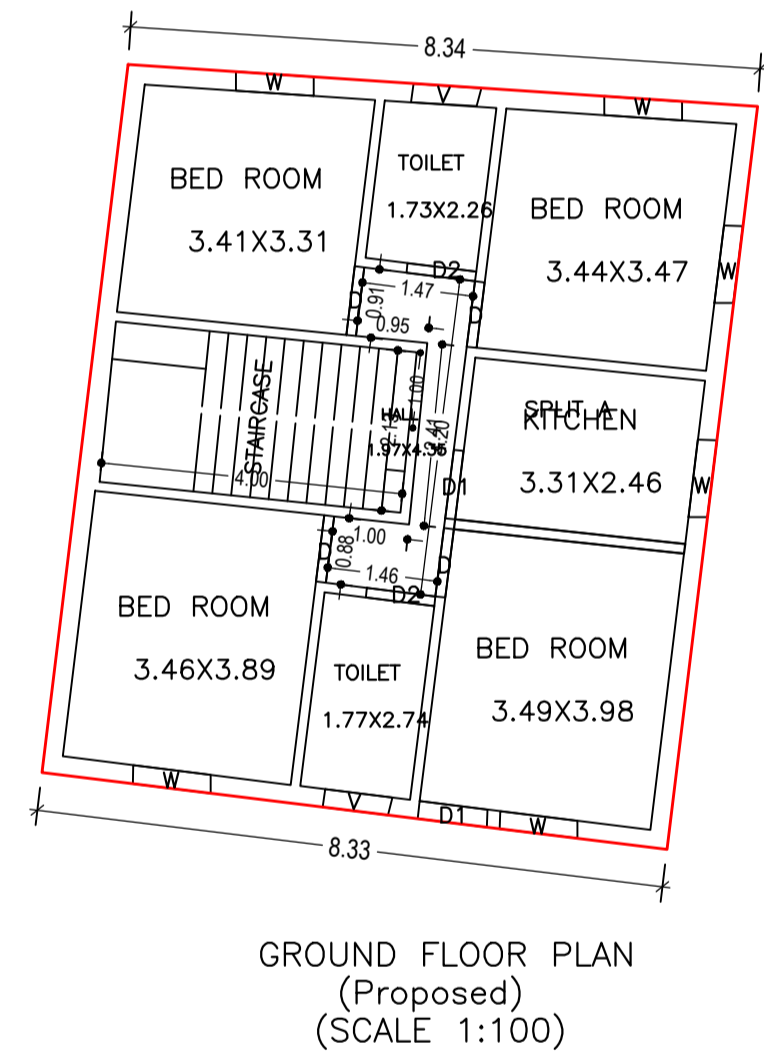
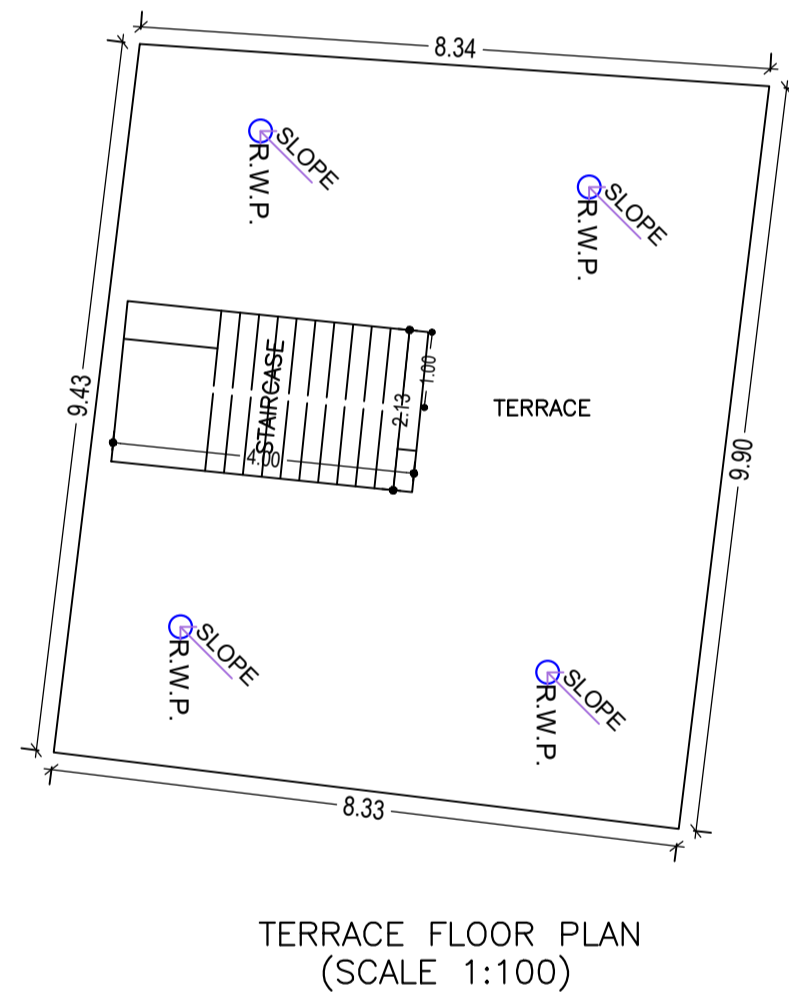

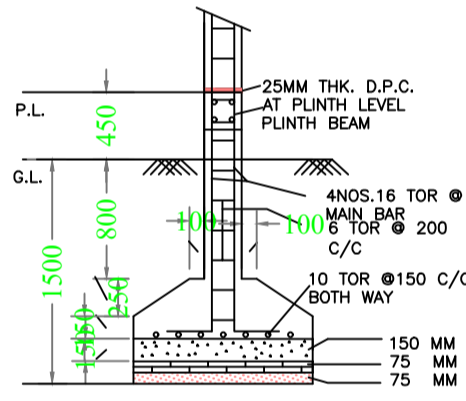
DETAIL OF SEPTIC TANK & SOAKPIT.



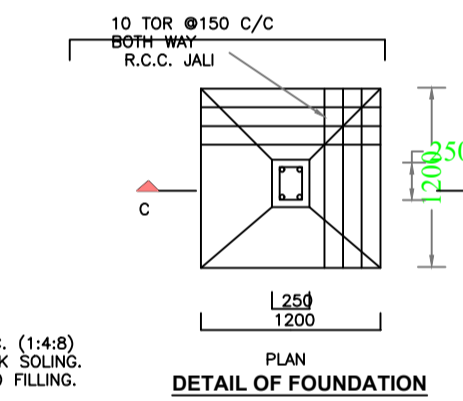
SEPTIC TANK DETAIL



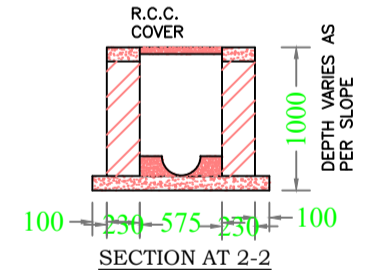
RAIN WATER STORAGE TANK DETAIL



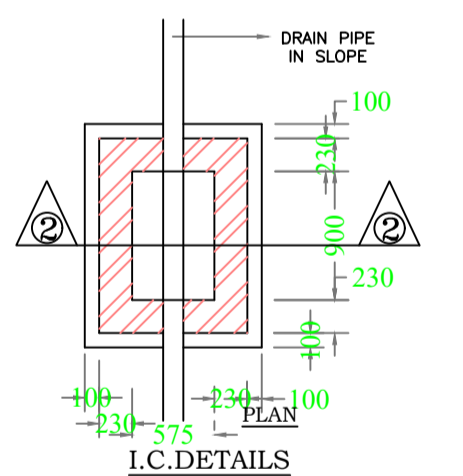
STRUCTURAL DETAIL
