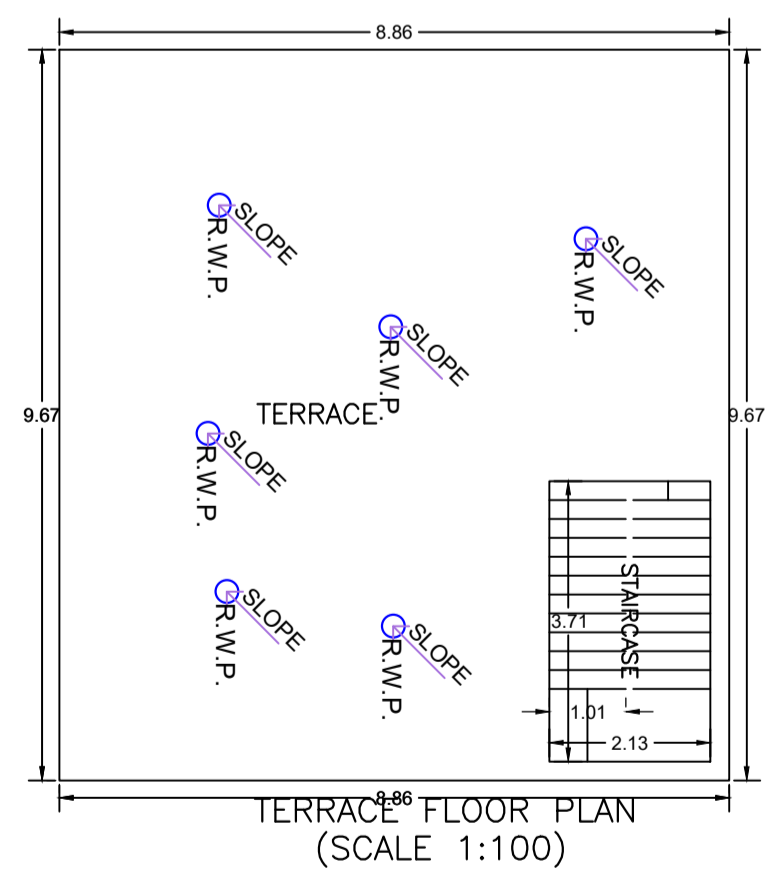
SITE PLAN



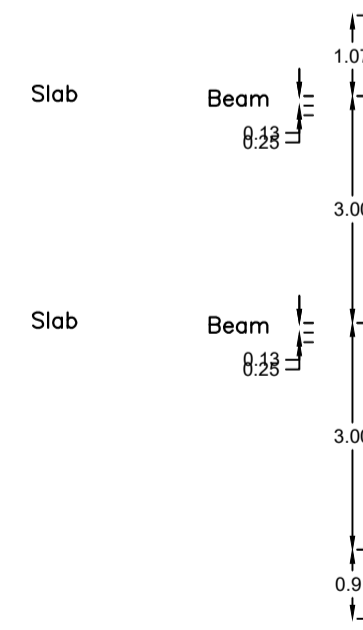
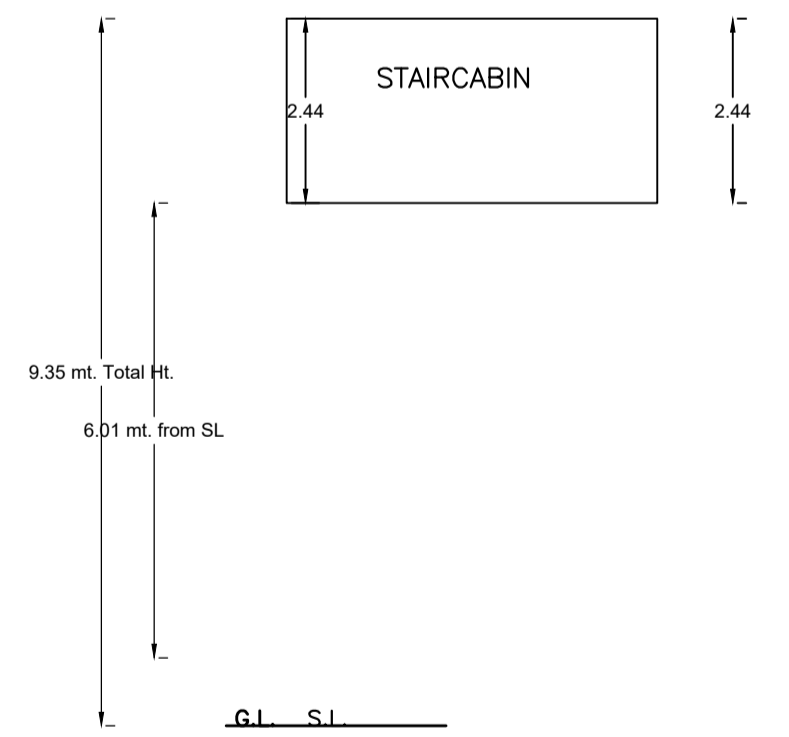
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)

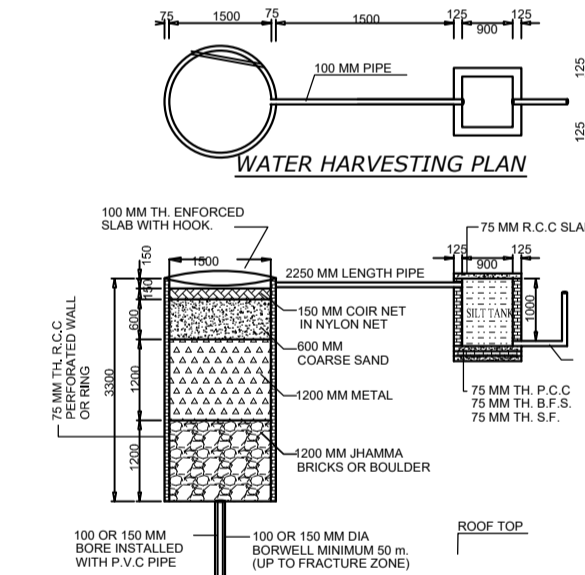

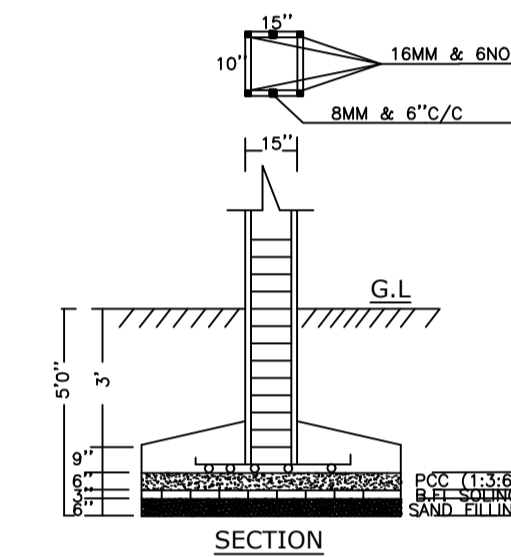
PLAN OF SEPTIC TANK



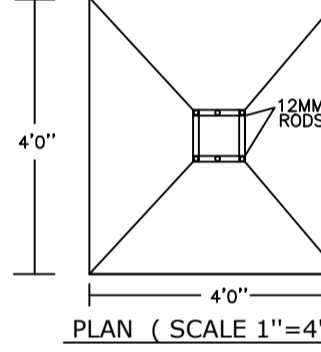
WATER HARVESTING PLAN
