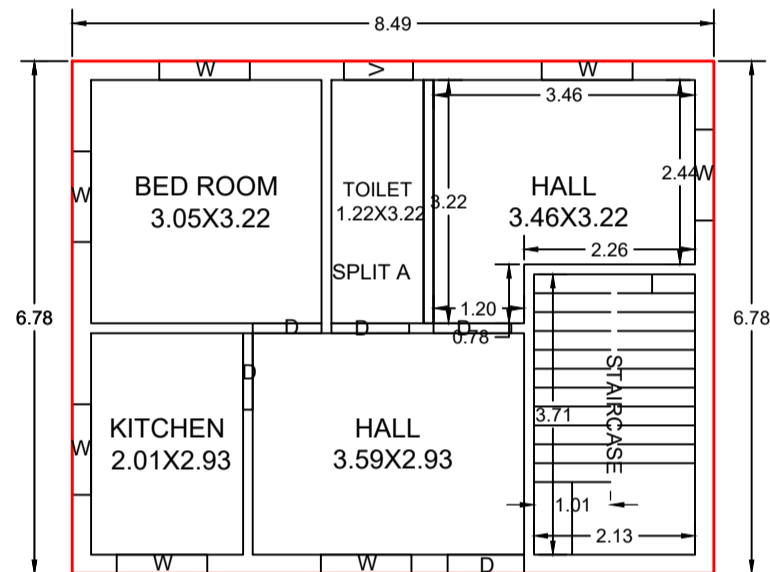
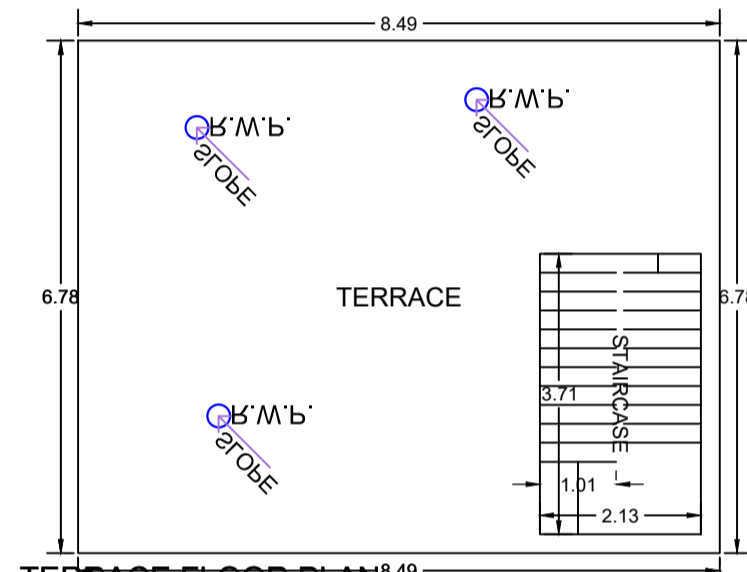


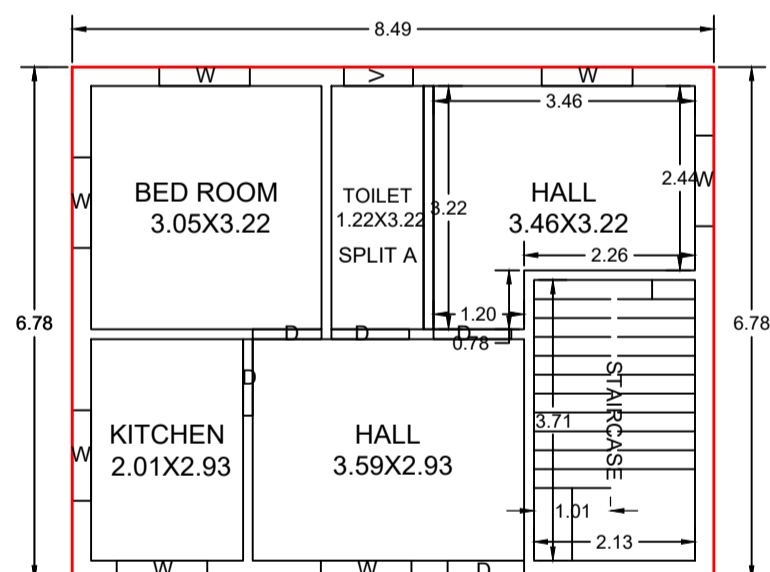

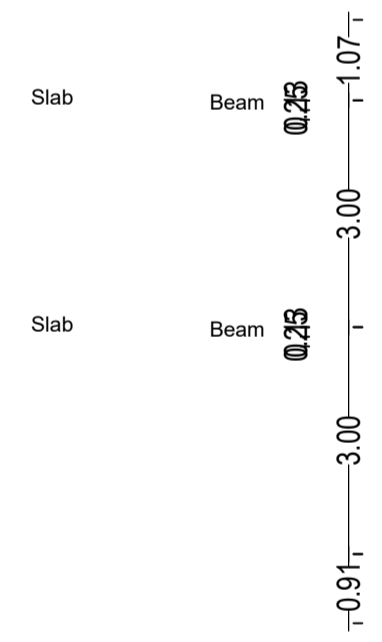
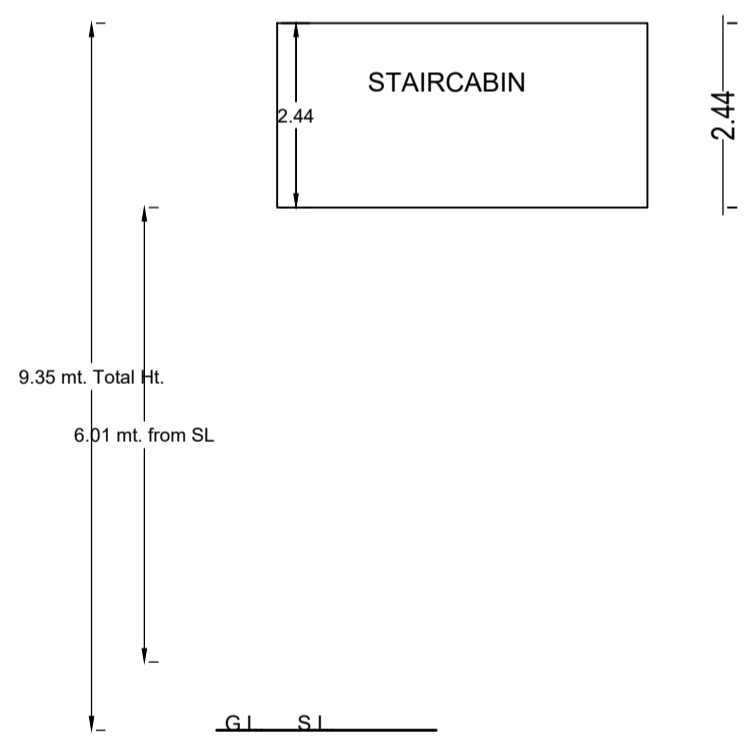
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)
