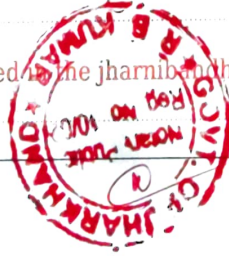

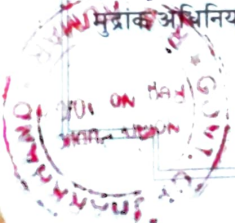

WHEREAS the said Donor is the absolute owner in possession of land

And WHEREAS in order to construct building over a land mentioned herein
above the Donor has got a Building plan provisionally sanctioned by the
Madhupur Nagar Parishad vide building plan case no.

MNP/BP/0066/W22/2022 dt.04/03/2023 and WHEREAS for the development
and widening of road in front of the above mentioned the Donor has left a strip
of land for road widening and is ready to donate the said strip of land the state
mentioned schedule below for benefit of society as a whole.

NOW THIS DEED OF GIFT WITNESSETH AS FOLLOWS:-

1. That is pursuance of said mentioned and consideration of benefit to the
society as whole. The Donor out of this free will without correction or undue

influence from anybody whomsoever hereby convey, grant transfer and confirm into the said Donee "The State" all the strip of land measuring an area of 5.12 sqmt more fully described in schedule below and shown in red wash in the map attached herewith forming of this Deed.

And that the said Donee i.e the state and may from time to time and at all time after peaceably and quietly use the strip of land as public property and shall have liberty to construct the road etc. And that the Donor hereby declares that neither the donor nor his legal heirs, shall claim any right, title or interest

Over the scheduled land and shall not encroach the said strip of land .
