WHEREAS the said Donor is the absolute owner in possession of land measuring an area of 271.56 sqmt

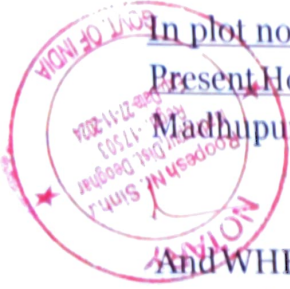

1. That is pursuance of said mentioned and consideration of benefit to the society as whole. The Donor out of this free will without correction or undue



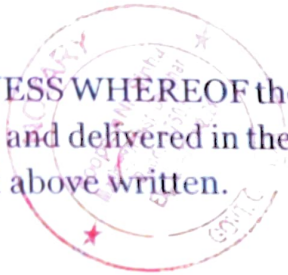
