

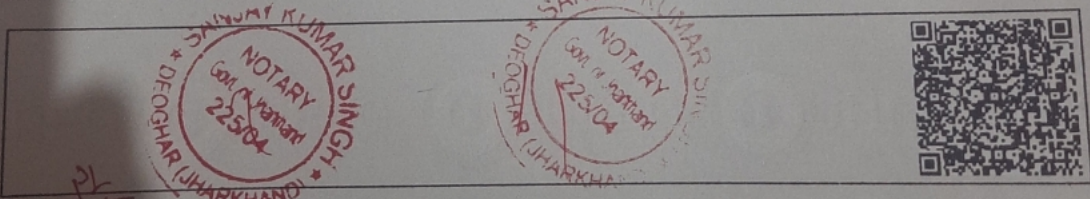

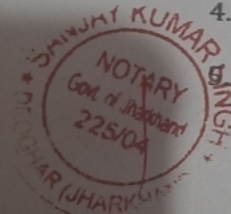
GIFT DEED OF LAND

That the above statements are true to the best of my knowledge, information and belief.


