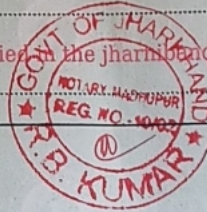
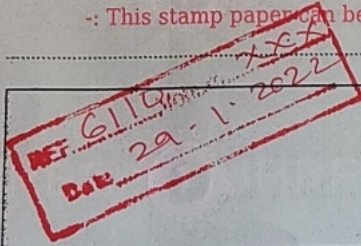

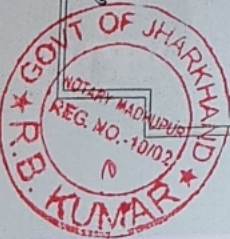

BETWEEN

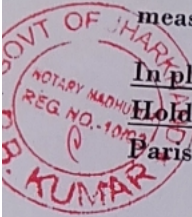

NOW THIS DEED OF GIFT WITNESSETH AS FOLLOWS:-

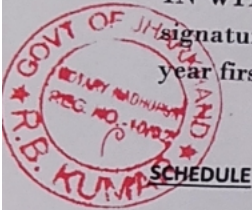
1. That is pursuance of said mentioned and consideration of benefit to the society as whole. The Donor out of this free will without correction or undue

And that the said Donee i.e the state and may from time to time and at all time after peaceably and quietly use the strip of land as public property and shall have liberty to construct the road etc. And that the Donor hereby declares that neither the donor nor his legal heirs, shall claim any right, title or interest

Over the scheduled land and shall not encroach the said strip of land .

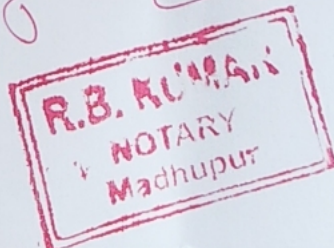
