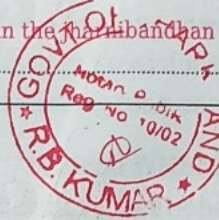
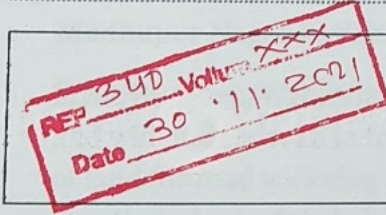

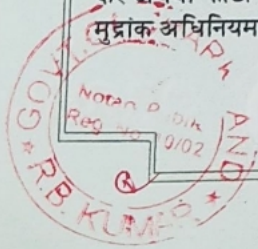

BETWEEN

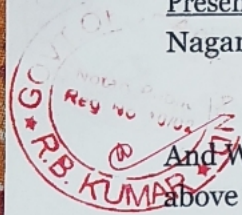

NOW THIS DEED OF GIFT WITNESSETH AS FOLLOWS:-

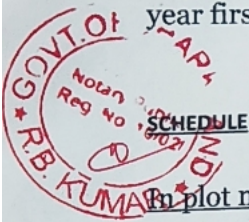
1. That is pursuance of said mentioned and consideration of benefit to the society as whole. The Donor out of this free will without correction or undue
